Dear Mr. Evers:

This letter responds to your request for information under the Public Information Act, Chapter 552 of the Texas Government Code (the "PIA"), which was received by the Office of the Texas Secretary of State (the "Office") via email on February 24, 2020 (the "Request").¹ In your Request, you indicate that you are seeking the following records dating back to November 1, 2019:

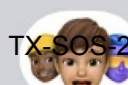

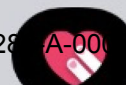
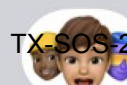
