**Re: Freedom of Information Act (FOIA) Request 2020-REE-03063-F
Final Response**

Dear Mr. Evers and Mr. Salvador:

This is the Research, Education, and Economics (REE) mission area's **final response** to the above referenced FOIA request. This correspondence also responds to the matter of *American Oversight, et al. v. U.S. Department of Agriculture, et al.*, Civil Action No. 20-1259-EGS, currently pending in the U.S. District Court for the District of Columbia.

The pending Complaint in the above referenced matter is based on USDA's alleged failure to comply with the applicable time-limit provisions of the FOIA in response to American Oversight (AO) and the Union of Concerned Scientist's (UCS) request for the following:

All records reflecting site visits to the location finalists for the relocation of the USDA's Economic Research Service and National Institute of Food and Agriculture. This request includes, but is not limited to, the following:

- i. Records sufficient to identify all federal officials, employees, and/or contractors invited to attend each site visit;*
- ii. Records sufficient to identify all federal officials, employees, and/or contractors who actually attended each site visit;*
- iii. Any documents identifying the buildings visited;*
- iv. Itineraries and/or agendas;*
- v. Briefing or other informational materials;*
- vi. Any hard copy materials provided to federal officials, employees, and/or contractors during the site visits;*
- vii. Any handwritten or electronic notes taken during site visits;*

- viii. *Summaries of any site visits created after the fact; and*
- ix. *All email and text communications relating to the site visits, and attachments thereto.*

Please provide all responsive records from May 3, 2019, through June 13, 2019.

On March 17, 2020, pursuant to USDA regulation 7 C.F.R. § 1.4(c), the Office of Information Affairs (OIA), FOIA Division routed a copy of your request to the REE mission area for processing and direct response to you.

REE issued interim responses on August 17, 2020 and September 25, 2020, concluding the electronic portion of your request. Subsequently, REE continued processing the manual portion of your FOIA request.

Your request has been processed under the FOIA, 5 U.S.C. § 552.

Search Efforts

Manual searches for responsive records were conducted by the REE mission area. The searches did not locate any records that are responsive to your FOIA request. As a result, the FOIA Division is not able to provide any responsive records.

In light of the matter *American Oversight, et al. v. U.S. Department of Agriculture, et al.*, Civil Action No. 20-1259-EGS, currently pending in the U.S. District Court for the District of Columbia, administrative appeal rights are not being provided in this response letter.
