**Re: Freedom of Information Act (FOIA) Request 2020-DA-02838-F
Third Interim Response**

Dear Mr. Evers and Mr. Salvador:

This is the Office of Information Affairs (OIA), FOIA Division's **third interim** response to the above referenced FOIA request. This correspondence also responds to the matter of *American Oversight, et al. v. U.S. Department of Agriculture, et al.*, Civil Action No. 20-1259-EGS, currently pending in the U.S. District Court for the District of Columbia.

The pending Complaint in the above referenced matter is based on USDA's alleged failure to comply with the applicable time-limit provisions of the FOIA in response to American Oversight (AO) and the Union of Concerned Scientist's (UCS) request for the following records:

1. *All records reflecting any cost-benefit analysis of relocating USDA employees outside of the National Capital Region.*

Requesters believe that USDA is in the best position to identify the custodians of responsive records. However, we request that USDA search, at a minimum, records of Deputy Secretary Stephen Censky, Acting Deputy Assistant Secretary Donald Bice, and Chief Economist Robert Johansson.

Please provide all responsive records from January 1, 2018, through August 15, 2018.

2. *The complete copy of the "NIFA and ERS Relocation: Cost Benefit Analysis," the Executive Summary of which was published on June 13, 2019, in conjunction with the*

announcement of the Kansas City Region as the new location for the Economic Research Service and National Institute of Food and Agriculture. This request includes any and all underlying records on which this Executive Summary was based.

3. *All electronic communications (including emails, email attachments, calendar invitations, calendar invitation attachments, or text messages) sent by (a) the USDA officials listed below to (b) any members of Congress or congressional staff, including anyone communicating with an email address ending in senate.gov or mail.house.gov.*

On March 17, 2020, pursuant to USDA regulation 7 C.F.R. § 1.4(c), the FOIA Division routed parts of Item 3, specifically vi and vii, to the REE mission area for processing and direct response to you.

Your request is being processed under the FOIA, 5 U.S.C. §552. The FOIA Division responded to Item 3 in full on May 11, 2020 and Item 1, in part, on July 27, 2020. Today's release responds in part to Item 2 above. The FOIA Division is continuing to review potentially responsive records for the remainder of Items 1 and 2.

Search Efforts

An electronic search for responsive records was conducted by the Client Experience Center's (CEC) eComply team. For this third interim, the FOIA Division reviewed a total of three hundred sixty-three (363) pages of emails and the accompanying attachments. These pages are being released today with Bates numbers 0082-0444.

A manual search and the review of potentially responsive records to Item 2 of your request is ongoing. The FOIA Division has determined certain information contained in the records released

in this response should be withheld pursuant to 5 U.S.C. § 552(b)(5) and (b)(6) (FOIA Exemptions 5 and 6). Additionally, two hundred twenty-two (222) pages of responsive records have been withheld in their entirety under Exemption 5. Below is an explanation of the information that has been withheld.

Application of 5 U.S.C §552(b)(5) “FOIA Exemption 5”

FOIA Exemption 5 protects from disclosure those “inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency.” 5 U.S.C. §552(b)(5). This language is construed to protect records that are normally privileged in the civil discovery context, including through the deliberative process privilege, the attorney-client privilege, and attorney work-product. As an initial matter, the information withheld meets the threshold requirement because it is contained in internal emails sent between federal employees. Where possible, the FOIA Division has determined to make discretionary releases of information that falls within the protection of Exemption 5.

In this instance, the FOIA Division is withholding, under the deliberative process privilege, pre-decisional inter- and intra-agency electronic communications relating to the Cost-Benefit Analysis (CBA) for the Economic Research Service (ERS) and National Institute of Food and Agriculture’s (NIFA) relocation, including discussions that fall under the consultant corollary doctrine and communications with regard to meeting agendas and drafts of the CBA. The FOIA division is also fully withholding drafts of the CBA. Disclosure of such information would have a chilling effect on the ability of agency officials to engage in free and frank discussions regarding policy but also may cause confusion on the agency’s actual position on the policy at issue.

The FOIA Division is also withholding information under the attorney-client privilege. This privilege protects confidential communication between an attorney and his/her client relating to a legal matter for which the client has sought professional advice. Although this privilege fundamentally applies to facts divulged by a client to his/her attorney, this privilege also encompasses any opinion given by an attorney to his/her client based upon those facts, as well as communications between attorneys that reflect client supplied information. In this instance, the FOIA Division is withholding information that would reveal the substantive content of communications between clients and their counsel.

Application of 5 U.S.C. §552(b)(6) “FOIA Exemption 6”

FOIA Exemption 6 permits the government to withhold information regarding individuals in “personnel, medical and similar files” when the disclosure of such information would constitute a clearly unwarranted invasion of personal privacy and where such privacy interests outweigh any public interest that would be advanced by disclosure. For purposes of the FOIA, the public interest is advanced when disclosure of the requested information educates the public about the activities of the government.

The information withheld under Exemption 6 consists of cell phone numbers, unpublished business contact information, the email address belonging to an employee of the Executive

Office of the President (EOP), travel information, personal information, and a conference call passcode. The release of cell phone numbers, unpublished business contact information, and the email address belonging to an EOP employee could subject individual(s) to unwarranted or unsolicited communications, or even harassment. Moreover, a significant privacy right exists in an EOP employee's contact information, and that disclosure would not explain government activities if the employee and the office they work for are otherwise identified in the record. Here, the name of the EOP employee whose email address has been redacted is disclosed and their email address has been redacted in such a way as to permit the identification of the individual to which they pertain. Although the release of individuals' travel information or personal information would not likely result in unsolicited communications, this information is private in nature and its release does not shed light on governmental operations. Regarding the conference call access code, participants of a conference call have a privacy interest in ensuring that no uninvited person is listening in on their calls. The release of passcodes could undermine the privacy of those calls. Since there is a viable privacy interest that would be threatened by disclosure, Exemption 6 authorizes this office to withhold the information. Accordingly, the FOIA Division has determined that the public interest in the information's release does not outweigh the overriding privacy interests in keeping it confidential.

In light of the matter *American Oversight, et al. v. U.S. Department of Agriculture, et al.*, Civil Action No. 20-1259-EGS, currently pending in the U.S. District Court for the District of Columbia, administrative appeal rights are not being provided in this response letter.

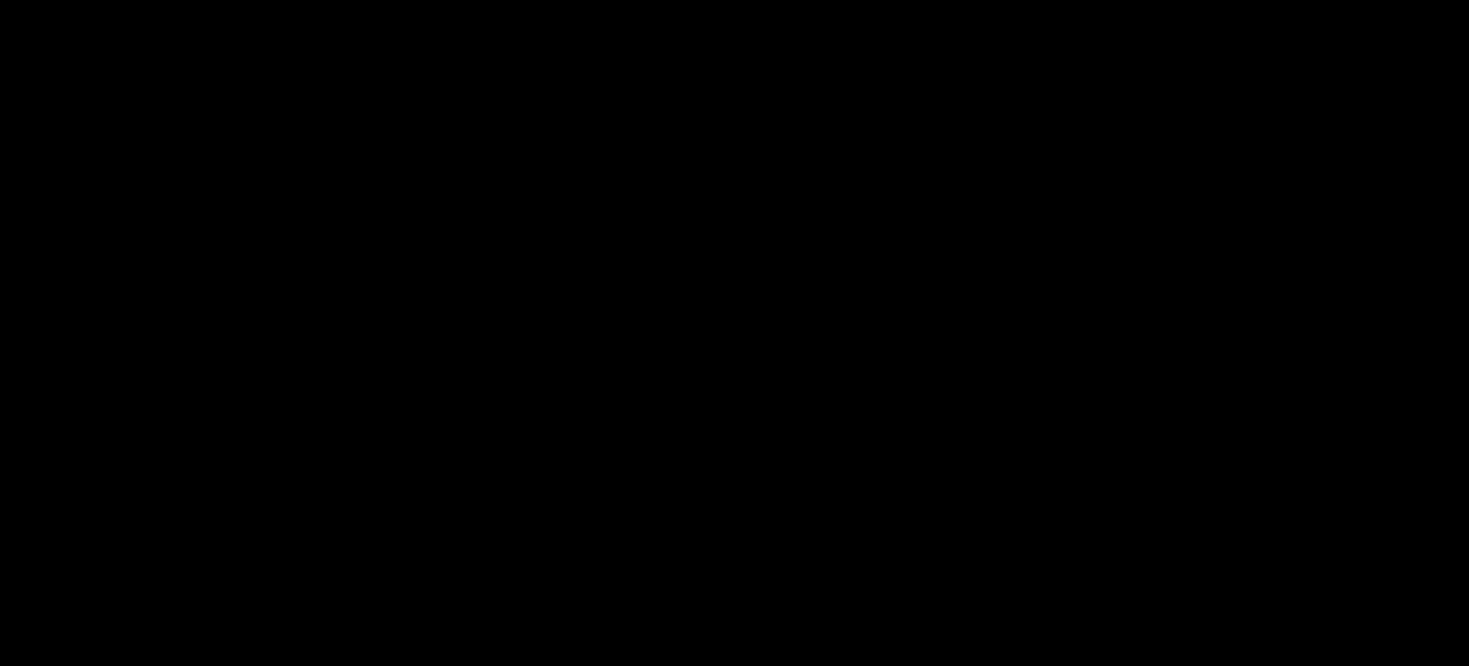
