Summary Description/Outcome of Event

This event was very important in that it was the first event we have done of its kind this election cycle. The GA Latino Alliance was having a voter information event. There were about 150-200 attendees and the event was live streamed on several social media platforms.

What made the event unique was that it was our first live fully translated Voter Education Demonstration of the new voting machine for Georgia. We had to have each set of instructions translated so the people in the room and the people online were able to fully understand what was being conveyed to them.

This led to a whole new set of questions as to why a county as large and as diverse as Fulton would not have a language translation option for Spanish on the machine. We discussed (they brought it up) that Gwinnett had this option but currently, Fulton did not. We were told that they would be calling the Secretary of State's office and Fulton County Elections Department as well because they were upset that this option was not available.

Beyond this conversation the demonstration was well received and they thanked us for coming out and spending the time needed to make sure they all understood the process.
