Dear Mr. Evers:

Your letter was received by electronic mail on March 24, 2020 and it has been assigned to the County's Law Department for a response. This letter serves as a timely response within three business days of receipt. For future reference, please note that Kristi Royston, succeeded Ms. Ledford as Elections Supervisor to the Gwinnett County Board of Registrations and Elections in the fall of 2019.

The following paragraphs set forth your request and respond to address the availability of the records:

All email communications (including emails, complete email chains, email attachments, calendar invitations, and attachments thereto) sent by any of the Gwinnett County officials listed below regarding any of the following public voting demonstrations, including, but not limited to, attendance logs, training guidelines, and post-demonstration notes: March 2, 2020, 7 p.m. to 8:30 p.m., Gwinnett Justice and Administration Center, 75 Langley Drive, Lawrenceville.

Please see attached the responsive records that are immediately available. The records are being transmitted electronically with correspondence. We anticipate being able to complete the search and provide you with any additional records by April 13, 2020.

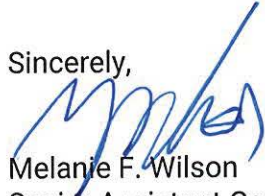
As authorized by O.C.G.A. § 50-18-71, the cost to search, retrieve, and copy the requested documents is calculated as follows: a charge of \$12.25 per hour after the first fifteen minutes and 10 cents per page. To date the cost incurred for this request are as follows: 1.25 hours, for which the first 15 minutes is at no cost and \$4.50 for the 45 pages of emails that were copied. We anticipate that the remaining search will take at least an hour. Please advise if you would like us to discontinue the search for records.

I will notify you immediately when I have accurate information regarding the cost of the remaining records and when the records are available. Thereafter, you will be required to remit the specified amount, payable to Gwinnett County, to the attention of Lynn Ledford, Division Director, Gwinnett Department of Community Services at 75 Langley Drive, Lawrenceville, Georgia 30046. Gwinnett County, its departments, agencies, boards, bureaus, commissions, authorities, and other similar bodies of Gwinnett County are authorized to collect this charge in
