Re: Records Request under NVRA

Dear Supervisor Antonacci, Chief Deputy Hall and Ms. Gibson:

Pursuant to the National Voter Registration Act of 1993 (“NVRA”), I am writing to request electronic copies of public records related to your voter list maintenance obligations. As you know, the NVRA requires each election county supervisor to make available “all records concerning the implementation of programs and activities conducted for the purpose of ensuring the accuracy and currency of official lists of eligible voters.” 52 U.S.C. 20507(i). To that end, I would like electronic copies of the following:

1. Current version of the Broward County Election Manual (manual for staff on how to process, verify, and otherwise handle new or re-registering voter registrations);
2. Any other manual, report, or documentation dated between June 1, 2017 and July 18, 2019, confirming that your office has taken actions to remove all ineligible voters from the voter roll, including documents and email reporting on:
 - a. Registrant names that were found on the Social Security Death Index or other source;
 - b. Registrant names that were found to have duplicate registrations on your roll;
 - c. Registrants who were sent address confirmation notices and documentation of the individual responses to each mailed notice;
 - d. Registrants whose registrations were cancelled, including the reason code for each cancellation;
 - e. Ineligibility letters sent to registered voters asking for verification of citizenship;
 - f. Notices published in print media identifying registrants whose registrations would be cancelled unless they respond to your office with needed information.
 - g.

The purpose of my request is to be able to obtain information about the procedures you have in place to ensure that list maintenance is occurring. Please give me a call or send me an email to discuss, if necessary. I am also available to come to your office this month to review records if they are not easily producible. Thank you in advance.
