Dear Austin Evers:

This is the fourteenth interim response to your Freedom of Information Act (FOIA) requests, dated and received in this Office on June 4, June 10, July 17, and August 6, 2020, seeking specified records concerning the nationwide protests following the killing of George Floyd and specified orders, directives, or guidance governing the Department's officers, agents, or members.

As we previously advised, searches have been conducted in OAG and ODAG and records responsive to your requests were located. At this time, the consultation process is completed for fifteen pages which were pending consultation with other Department components and Executive Branch agencies. Specifically, three pages are from our second interim response dated March 5, 2021, six pages are from our third interim response dated April 5, 2021, four pages are from our fifth interim response dated June 21, 2021, and two pages are from our sixth interim response dated July 8, 2021. All fifteen pages¹ are appropriate for release with withholdings made pursuant to Exemptions 3, 6, 7(C), 7(E), and 7(F) of the FOIA, 5 U.S.C. § 552(b)(3), (b)(6), (b)(7)(C), (b)(7)(E), and (b)(7)(F), and copies are enclosed. Exemption 3 pertains to information exempted from release by statute, in this instance 50 U.S.C. § 3024(i)(1), Exemption 6 pertains to information the release of which would constitute a clearly unwarranted invasion of personal privacy, Exemption 7(C) pertains to records or information compiled for law enforcement purposes, the release of which could reasonably be expected to constitute an unwarranted invasion of personal privacy, Exemption 7(E) pertains to records or information compiled for law enforcement purposes, the release of which would disclose certain techniques and procedures or guidelines for law enforcement investigations or prosecutions, and Exemption 7(F) pertains to records or information compiled for law enforcement purposes, the release of which could reasonably be expected to endanger the life or physical safety of an individual.

¹ Please note that certain information contained in a gray box marked "Pending Consultation" on the first page of Document ID: 0.7.5603.5095-000001 is still pending consultation with another Department component. An updated version of this page will be released once this consultation process is completed.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c) (2018). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

Civil Unrest Daily Briefing

SUBJECT: Daily Briefing for June 29, 2020, as of 1900

I. Overview

- DHS and FBI SitReps for this reporting period indicate that protests in Portland and Richmond were relatively subdued with no substantial acts of violence or vandalism noted in either city. Similarly, nationwide, there were no reports of significant vandalism to federal property or injuries to federal law enforcement officers. There were two shootings in Seattle early this morning. The U.S. Attorney for the Western District of Washington reported that this event now makes six shootings in a small area of the city known for its low rate of violent crime. Finally, the DOD has completed DOJ's request to place an aircraft on alert near the USM (b)(7)(E) per USMS facility in Louisiana. (See attached photo)

II. Reported Activity & Potential Hotspots

- Richmond, VA: Daily protest activity continues at the Robert E. Lee statue. Virginia State Police and the Richmond Police Department are staged in the area. A 22-year-old male from Chesapeake, VA was arrested in Richmond after being stopped at 2130 ET on Saturday night for traveling the wrong way on a road near downtown Richmond. The driver attempted to flee but was taken into custody. Police found an active incendiary device, a hand saw, wooden shields, a gas mask, and a shovel fashioned into a spear in his vehicle. It is not known if the driver was or intended to be involved with demonstrations. The investigation is ongoing. (DHS Support to Civil Disturbances, June 28)
- Portland, OR: There were no reports of injury to federal law enforcement officers or impact to federal property. Protesters blocked roads around the Justice Center and the nearby Edith Green-Wendell Wyatt Federal Building again Sunday night, following eight arrests on Saturday night after demonstrators pulled barriers into a main intersection there and resisted police efforts to remove them. (DHS Support to Civil Disturbances, June 29)
- Seattle, WA: Protest activity was again relatively subdued, with no reported damage to federal facilities. However, early on Monday morning, two people were shot in the in the Capitol Hill Occupied Protest (CHOP) zone. One of the victims died and the other is in critical condition. This incident now makes six shootings within the same seven-block region area of Seattle within the last month of Seattle. This seven-block area of Seattle is within a part of the city that, historically, has had few incidents of violent crime. - Columbia, SC: On June 28, the South Carolina Law Enforcement Division Bomb Squad responded to the South Carolina State House after an incendiary device detonated at the base of the Benjamin Tillman monument. There was minimal damage to the monument. (FBI LES SitRep, June 28)
- Washington, DC: There were no reports of injuries to law enforcement or damage to federal facilities. (DHS Support to Civil Disturbances, June 29)

SUBJECT: Civil Unrest Updates for June 2, 2020

I. City Reports

- D.C. had a better night last night. Also, SIOC worked reasonably well.
- According to open sources, New York experienced extensive looting and unrest.
- There were a number of serious attacks on police around the country, including in Las Vegas, St. Louis, New York, and Richmond (see below).
- In St. Louis, we were successful in getting DEA to support other FLEOs in maintaining order, and US Attorney Jeff Jensen visited the injured officers in the hospital.

II. Updated List of Federal Charges

- At least (b)(7)(E) per FBI defendants to date have been charged with federal crimes, including violations of 18 U.S.C. §§ 842(p)(2)(A), 844(i), and 2101.
- There are at least (b)(7)(E) per FBI investigations in which federal charges are being considered.
- We have a number of additional investigations at various stages involving the use of Molotov cocktail type devices, and potential violations of 18 U.S.C. §§ 2101, 231, and 844(i).

IV. FBI Intelligence

- Overall, ten field offices report (b)(7)(E) per FBI protesters were arrested.
- (b)(7)(E) per FBI
- Protesters have damaged federal facilities in fourteen cities from May 29 June 1.
 - While most of the reported damage was minor vandalism, such as broken windows and graffiti, facilities in Detroit and Portland sustained significant damage.
 - There was no significant damage reported to FBI facilities; four FBI field offices reported graffiti and Detroit also reported four broken windows.
- Protests in each city have ranged in size, and those with counter-protestors have represented a small fraction of the total.
- There are reports suggesting the individuals involved in or present at locations of unrest are part of anti-government/anti-authority extremism, militia extremism, racially or ethnically motivated violent extremism, or violent gangs. Yet, much of the violence and vandalism is perpetrated by opportunistic, individual actors acting without specific direction.
 - The FBI continues to aggressively attempt to corroborate whether or not there is in fact an organized effort to incite violence by either known criminal groups or domestic violent extremists.

V. Attacks on Officers

- There have been several incidents of officers being shot at throughout the night. We have checked in with the USAs in those districts.
 - *St. Louis, MO* 4 police officers shot in St. Louis, MO and are

expected to survive. At least one other officer took fire inside his vehicle, but was not hit. There have been reports of gunfire in the vicinity of the federal building and there are reports of other shooting victims throughout the area. In general, St. Louis appears to have had a difficult and violent night.

- *Las Vegas, NV* there were two reported shootings. The first is a Metro Police Department officer who was shot in the face on the Las Vegas Strip and, as of this writing, is in extremely critical condition. The shooter has been apprehended. It is not clear if the motive was protest-related. The second shooting was at the Federal Courthouse in Las Vegas, where Metro Police Department officers fired on an armed suspect. The suspect was killed.
- *Richmond, VA* two officers and one civilian were shot and injured. It is currently unclear if this is related to the violent protests, but the initial belief is that it is. One officer's injury is life threatening. The other officer and the protestor did not sustain life-threatening injuries.
- *Buffalo, NY* at about 9:40 p.m., two officers were hit by an SUV vehicle that ran a police line. The officers sustained a broken pelvis and a broken leg. The driver and occupants of the vehicle were arrested.
- *New York, NY* a NYPD officer was injured in an apparently purposeful hit-and-run incident connected to the violent protests.

II. Reported Activity & Potential Hotspots

- Portland, OR: Late-night demonstrations on Thursday resulted in four arrests, smashed store windows, looting, and fires set at Portland Police's North Precinct, with hundreds demonstrating at or near the Multnomah County Justice Center. Additionally, the federal building that houses the U.S. Attorney's Office and federal district courts sustained further damage from vandalism and attempted arson. (DHS Support to Civil Disturbances, June 27; U.S. Attorney for the District of Oregon, June 27)
- New Orleans, LA: Demonstrations planned after 1900 EDT that may attempt to pull down the statue of Andrew Jackson. Reports of counter-demonstrations have also been received. (USAO New Orleans, LA, June 26)
- San Antonio, TX (b)(7)(E) per FBI [REDACTED]

- Washington, DC: Protesters returned to the Lincoln Park Emancipation Monument on Friday evening to continue calls for the statue's removal. On 27 Jun NGB reported 139 Guardsmen activated in response to DC civil disturbances. (DHS, June 27)

 - NDOH Timothy Goodner was identified as one of the individuals who set a parking ticket booth on fire during a riot in downtown Cleveland on 30 May. Goodner was originally arrested on local charge on 25 June and then taken into federal custody via complaint on 26 June. (USAO NDOH, June 26)

SUBJECT: Daily Briefing for July 2, 2020, as of 1800

I. Overview

- The DHS SitRep for this reporting period indicated that demonstrations in Portland and Seattle grew violent overnight, as protestors clashed with police, started fires, and damaged property. There were no reports of attempts to remove any memorials, although there were attempts to damage the Federal courthouse and U.S. Attorney's Office in Portland. There are currently 573 National Guard personnel deployed across six states and D.C. for civil disturbance support. Since May 25, there have been a total of 63 incidents of damage to federal property or landmarks.

II. Reported Activity & Potential Hotspots

- Portland, OR: A group of approximately 250 protestors removed protective plywood coverings and spray-painted the federal courthouse, in addition to shooting fireworks, pointing lasers, and throwing multiple objects at FPS units and U.S. Marshals. There were no reported injuries to federal law enforcement officers and no unauthorized entries into the courthouse. (FBI LES SitRep, July 2; DHS Support to Civil Disturbances, July 2)
- Seattle, WA: Protestors gathered near the federal courthouse and failed to heed warnings by the police to stay back. The crowd eventually began throwing bottles at the police. Seattle Police reported 44 arrests as of Tuesday. (FBI LES SitRep, July 2; DHS Support to Civil Disturbances, July 2)
- Gettysburg, PA: Open source reporting and social media indicate that an anti-fascist group plans to vandalize the Gettysburg National Cemetery on July 4. Law enforcement and public safety agencies are also tracking a possible flag burning event scheduled for July 4 in the same cemetery. No specific or credible threats to federal land or property have been identified. (DHS Support to Civil Disturbances, July 2)
- South Dakota: On July 3, POTUS, family members, and other officials arrive at Mount Rushmore for a July 4 fireworks celebration. Several Native American-led protests and an "anti-Trump" rally are scheduled to coincide. (DHS Support to Civil Disturbances, July 2)
- Columbia, SC: Police arrested two people for attempting to blow-up a statue on the grounds of the South Carolina state capitol. The device did not explode and caused no permanent damage to the statue. (DHS Support to Civil Disturbances, July 2)
- Washington, D.C.: There was very little protest activity overnight. There are no reports of injury to law enforcement officers or damage to federal facilities. (DHS Support to Civil Disturbances, July 2)

- Case Snapshots:
 - DC Jason Charter was arrested by the FBI and Park Police on Thursday morning. He is the ringleader and third of three individuals who have been arrested for their role in the destruction of the Andrew Jackson monument in Lafayette Square. The search continues for the fourth individual. (Open Source Reporting)
 - WDNY [PARTIALLY SEALED] Marquis Frasier, MacKenzie Drechsler, Dyshika McFadden, a (b)(6) per EOUSA were each charge for acts related to the use of Molotov cocktails to set fire to a construction trailer, a state government vehicle, a local government vehicle, and a Rochester Police Department vehicle. (b)(6) per EOUSA Drechsler, and Frasier had their initial appearances before a Magistrate this afternoon. [SEALED] McFadden is expected to have his initial appearance early next week.
 - CDCA - Defendant Micah Tillmon, 19, was arrested yesterday morning by ATF Los Angeles on a criminal complaint charging one count of arson. According to the complaint, Tillmon is alleged to have started a fire causing substantial damage to a restaurant in Santa Monica. The defendant will made his initial appearance today. The charge carries a 5 year mandatory minimum.
