Dear Requester:

This letter is in final response to your Freedom of Information Act (FOIA) request dated June 25, 2020 for the following:

1. All records reflecting any order, directive, or guidance regarding the National Guard use of force guidelines, policies, doctrines or protocols rules of engagement, deployment of National Guard members,
2. All records regarding the National Guard's rules of engagement (including, but not limited to, all records specifying intervention criteria),
3. All records regarding the deployment of the National Guard Bureau's officers, agents, or members (including, but not limited to, all records specifying logistical deployment information), and
4. All records regarding the visual or verbal presentation of law enforcement credentials identifying National Guard Bureau officers,, agents, or members deployed in response to protests or purported civil unrest (including, but not limited to, all records concerning verbal self-identification to members of the public or press, badge display standards or requirements, or name display standards or requirements).

Your request was received by the National Guard Bureau on June 25, 2020 and assigned case #J-20-0150.

A search for responsive documents by knowledgeable staff in the NGB's Law Enforcement Support Branch failed to locate any documents that would be responsive to your request. The FOIA applies only to existing records and there is no requirement to create a records in order to respond to a FOIA request.

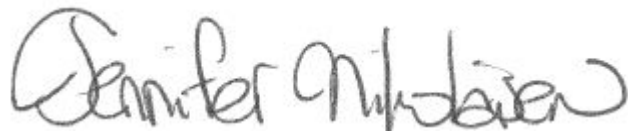

If you use e-mail, please have the words "FOIA Appeal" in the subject of the email. Your appeal must be postmarked or electronically transmitted within 90 days of the date of this response and should include copies of your original request and this response, as well as a discussion of the reasons supporting your appeal.
