Dear Mr. Evers:

This is the final response to your Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS), dated August 13, 2020, and received by this office on August 14, 2020. You are seeking all records reflecting any order, directive, guidance, or memorandum (including) informal direction distributed to your agency's officers, agents, or members) regarding the implementation of Operation Legend, including but not limited to any guidance or directives regarding the visual or verbal presentation of law enforcement credentials by officers and agents deployed as part of Operation Legend, or any guidance regarding the enforcement priorities of officers and agents deployed as part of Operation Legend.

We conducted a comprehensive search of files within the Office of the General Counsel (OGC) for records that would be responsive to your request. Unfortunately, we were unable to locate or identify any responsive records.

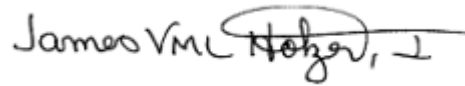
While an adequate search was conducted, you have the right to appeal this determination that no records exist within OGC that would be responsive to your request. Should you wish to do so, you must send your appeal and a copy of this letter, within 90 days of the date of this letter, to: Privacy Office, Attn: FOIA Appeals, U.S. Department of Homeland Security, 2707 Martin Luther King Jr. Avenue, SE, Mail Stop 0655, Washington, D.C. 20528-0655, following the procedures outlined in the DHS FOIA regulations at 6 C.F.R. Part 5 § 5.5(e)(2). Your envelope and letter should be marked "FOIA Appeal." Copies of the FOIA and DHS FOIA regulations are available at www.dhs.gov/foia.

Additionally, you have a right to right to seek dispute resolution services from the Office of Government Information Services (OGIS) which mediates disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. If you are requesting access to your own records (which is

considered a Privacy Act request), you should know that OGIS does not have the authority to handle requests made under the Privacy Act of 1974.
