Dear Mr. Evers:

On August 31, 2020, the Office of the Governor received your request for the following records under the New Mexico Inspection of Public Records Act (NMSA 1978, §§ 14-2-1 to -12) ("IPRA"):

All email communications (including emails and email attachments) sent by 1) Governor Lujan Grisham, Chief of Staff John Bingaman, or Deputy Chief of Staff Elizabeth Armijo, to 2) anyone communicating from an email address ending in eop.gov.

Please provide all responsive records from July 15, 2020, through the date the search is conducted.

In an effort to accommodate your office and reduce the number of potentially responsive records to be processed and produced, American Oversight has limited its request to emails sent by the above officials. To be clear, however, American Oversight still requests that complete email chains be produced, displaying both sent and received messages. This means, for example, that both an official's response to an email from an eop.gov email address and the initial received message are responsive to this request and should be produced.
