Dear Mr. Evers:

This is the final response to your Freedom of Information Act (FOIA) request, dated September 25, 2020, to the U.S. Department of Agriculture's Food Safety and Inspection Service (FSIS). You requested a copy of calendar invitations and e-mails sent by Paul Kiecker containing the key terms: Plylar; Mountaire; mountaire.com; Scuse; and Sheila Grant from March 1, 2020, to June 30, 2020. We received your request in our office on October 2, 2020.

The FSIS FOIA staff works with subject matter experts across the agency to locate responsive documents. For this request, we conducted a records search in the Office of the Administrator, and the Office of the Chief Information Officer. FSIS' search began on October 2, 2020. Our search includes responsive records in FSIS' control on that date.

We have located 80 pages that are responsive to your request. After a thorough review, we have determined that portions of these documents are exempt from disclosure under (b)(4), and (b)(6) of the FOIA, 5 U.S.C. § 552, as amended. Additionally, we are withholding 24 pages in full under (b)(5). Accordingly, this request is granted in part.

Exemption 4 of the FOIA protects "trade secrets and commercial or financial information obtained from a person privileged or confidential." 5 U.S.C. § 552(b)(4). This exemption covers two distinct categories of information in federal agency records, (1) trade secrets, and (2) information that is (a) commercial or financial, and (b) obtained from a person, and (c) privileged or confidential. In this instance, the agency is withholding information related to line speeds, headcounts and production volume. We have determined that these records contain commercial or financial information that is customarily treated as private by the business submitters. Therefore, the information is considered confidential.

Some responsive records contain drafts, staff analyses, opinions, or recommendations. Those portions are deliberative and pre-decisional and are an integral part of the agency's decision-making process. They are exempt from the FOIA's disclosure requirements by FOIA Exemption 5, 5 U.S.C. § 552(b)(5).

Portions of the responsive records are exempt from disclosure under FOIA Exemption 6, 5 U.S.C. § 552(b)(6). Exemption 6 protects information that would constitute an unwarranted invasion of an individual's personal privacy. The types of information withheld under Exemption 6 include the names, addresses, or cell phone numbers of employees of Establishments and third parties, including, but not limited to interviewees or customers.

You may appeal this determination by email to FSIS.FOIA@USDA.GOV. Your appeal must be in writing, and it must be received electronically no later than 90 days from the date of this letter. FSIS will not consider appeals received after the 90 calendar-day limit. Appeals received after 5:00 PM EST will be considered received the next business day. Your appeal should include the FOIA tracking number, a copy of your original request, FSIS's response to your original request, as well as reasons supporting your appeal.
