Dear Mr. McGrath and Mr. Evers:

On behalf of the United States Department of Justice (DOJ), Justice Management Division (JMD), I am responding to your referenced Freedom of Information Act (FOIA) requests dated October 9, 2020, for DOJ visitor logs reflecting visitors who came to meet with Assistant Attorney General for the Civil Rights Division (CRT) Eric Dreiband from August 15, 2020, through the date the search is conducted.

We have conducted a search of JMD's visitor logs and enclosed are records responsive to your requests. JMD consulted with CRT which made redactions under FOIA Exemption 6 for certain personally identifiable information.

Your appeal must be postmarked or electronically transmitted within 90 days of the date

of my response to your request. If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
