Dear American Oversight:

While processing your Freedom of Information Act (FOIA) request dated October 9, 2020, for copies of all visitors logs for Attorney General Jeff Sessions, dating from June 25, 2018 through October 6, 2018, the Justice Management Division (JMD) located seventy-eight pages of material which it referred to this Office for processing and direct response to you. The JMD administrative tracking number for this request is JMD 124391. For your information, this material was received in this Office on February 7, 2022.

By email exchange, dated June 1, 2022, between Eric Hotchkiss of this Office and Katherine Anthony of your organization, you agreed that this Office would redact as “Non-Responsive Records” any entries that were not for a visitor of Attorney General Sessions. Your request has been processed accordingly.

I have determined that the seventy-eight pages of material referred by JMD is appropriate for release with certain information withheld pursuant to Exemptions 6 and 7C of the FOIA, 5 U.S.C. § 552(b)(6), and (b)(7)(C). Exemption 6 pertains to information the release of which would constitute a clearly unwarranted invasion of personal privacy. Exemption 7C pertains to records or information compiled for law enforcement purposes, the release of which could reasonably be expected to constitute an unwarranted invasion of personal privacy. Please be advised that we have considered the foreseeable harm standard when reviewing records and applying FOIA exemptions.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c) (2018). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."

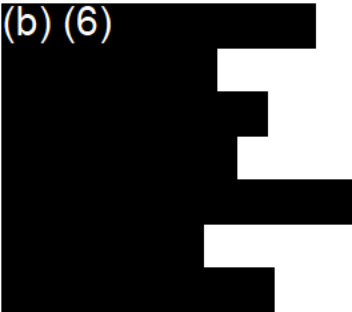
