Dear Mr. Evers:

This is the final response to your Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS), dated October 13, 2020, and received by this office on October 13, 2020. You are seeking any final orders, directives, guidance, memoranda, or analyses regarding any investigations, evaluations, reviews, or probes into (a) Black Lives Matter protestors or leadership, including but not limited to Patrisse Cullors, Alicia Garza, and Opal Tometi, or (b) Antifa protestors or purported leadership.

We conducted a comprehensive search of files within the Office of the General Counsel (OGC) and the Executive Secretariat (ESEC) for records that would be responsive to your request. Unfortunately, we were unable to locate or identify any responsive records.

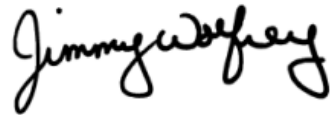
This office was also coordinating a search with the Office of Intelligence and Analysis (I&A) for records responsive to your request. Upon further review, we have determined that most requests related to this topic, including yours, should be handled at the Component-level rather than processed at Headquarters. Accordingly, you should expect to receive a final response directly from I&A. Please note that I&A is already in the process of searching for potentially responsive records to your request. We do not expect this administrative change to delay your response.

While an adequate search was conducted, you have the right to appeal this determination that no records exist within OGC and ESEC that would be responsive to your request. Should you wish to do so, you must send your appeal and a copy of this letter, within 90 days of the date of this letter, to: Privacy Office, Attn: FOIA Appeals, U.S. Department of Homeland Security, 2707 Martin Luther King Jr. Avenue, SE, Mail Stop 0655, Washington, D.C. 20528-0655, following the procedures outlined in the DHS FOIA regulations at 6 C.F.R. Part 5 § 5.5(e)(2). Your envelope and letter should be marked "FOIA Appeal." Copies of the FOIA and DHS FOIA regulations are available at www.dhs.gov/foia.

Additionally, you have a right to right to seek dispute resolution services from the Office of Government Information Services (OGIS) which mediates disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. If you are requesting access to your own records (which is considered a Privacy Act request), you should know that OGIS does not have the authority to handle requests made under the Privacy Act of 1974. Provisions of FOIA allow DHS to charge for processing fees, up to \$25, unless you seek a waiver of fees. In this instance, because the cost is below the \$25 minimum, there is no charge.
