Dear Mr. Evers:

Wayne County received the following request for records by email on November 19, 2020:

All email communications (including emails, email attachments, complete email chains, calendar invitations, and calendar invitation attachments) between (a) Chairperson Monica Palmer or Board Member William Hartmann, and (b) any of the following external parties, including but not limited to . . . specified email addresses . . . from November 3, 2020, through the date the search is conducted.

(Emphasis in original.)

Your request was forwarded to Chairperson Monica Palmer and Member Hartmann.² They were asked to review the request and forward any

responsive public records to our office. Your request must be denied, because, despite our request to Chairperson Palmer and Member Hartmann, we have not received any responsive records.

You have the right to do either of the following with regard to the denial of your request:

Submit a written appeal to the County Executive, which specifically states the word "appeal" and states the reason or reasons the denial should be reversed.

OR

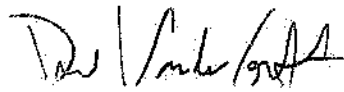
Commence an action in the circuit court to compel disclosure. Should you prevail, you will be entitled to have reasonable attorneys' fees, costs and disbursements assessed against the County by the court. If you or the County prevails in part, the court may, in its discretion, award you all or an appropriate portion of reasonable attorneys' fees, costs, and disbursements. If the court determines that the County has been arbitrary and capricious in its denial, you will also be entitled to punitive damages in the amount of \$1,000.00.
