I just ran a search that included only our domain name and @nevadagop. The search yielded zero communications with @nevadagop and Secretary Cegavske, anyone acting on her behalf, her Chief of Staff, Scott Anderson, or Wayne Thorley, former Deputy Secretary of State for Elections. There were a few emails sent to nvelect@sos.nv.gov from voters and @nevadagop was copied, but no direct communications whatsoever. We have one staff member who seems to be on a news alert/subscription service, but he has been deployed with the National Guard since January 2020 and there are no emails returned or any activity other than the individual getting periodic alerts. He does not work directly with the Secretary or her executive team.

If you have been following the news in Nevada, it really shouldn't come as a surprise that there are no communications with that organization and our office. Please let me know if you have any questions.
