can exit out any door.

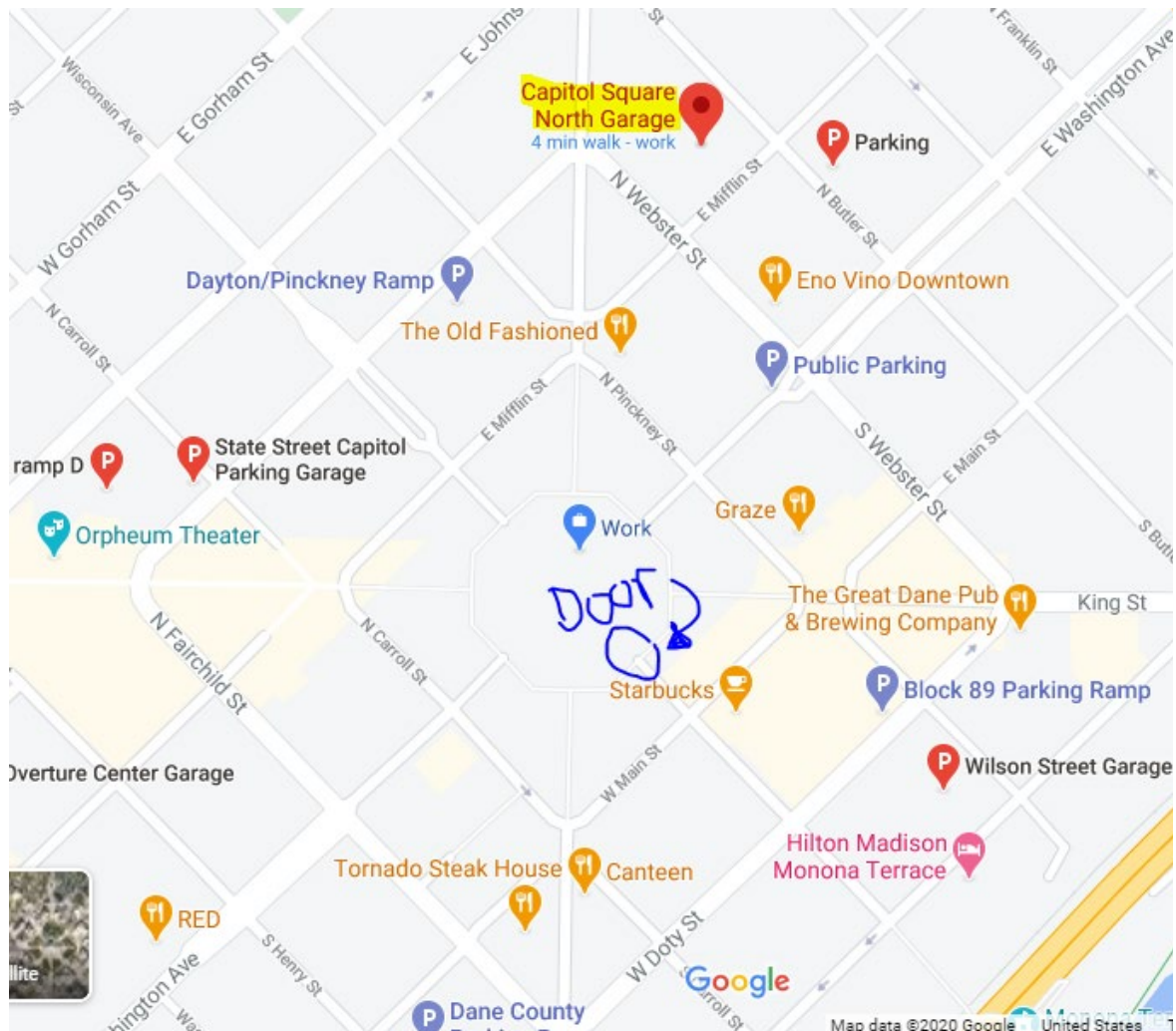
Coffee, water, soda and snacks will be provided in GAR or 417 North, take the north wing elevators to the 4th floor.
