RE: Consent Order – Change to Voter Assistance Laws

Pursuant to a Consent Order entered by United States District Judge Timothy Batten, you are directed to permit voters who are entitled to receive assistance to receive assistance from anyone of the voters' choosing, subject to the requirements of both Section 208 of the Voting Rights Act and O.C.G.A. § 21-2-409(b)(1) for the December 4, 2018 runoff and all future elections, regardless of whether a federal candidate is on the ballot.

This means that the provisions set forth in O.C.G.A. § 21-2-409(b)(2), which limited assistance in non-federal elections to only relatives and people within the precinct, cannot be enforced. Voters are entitled to receive assistance due to inability to read the English language or disability rendering them unable to see or mark the ballot/DRE, and these voters are allowed to select any person of their choosing except their employer or agent of that employer or officer or agent of the voter's union. Further, there is no longer a limitation on the number of people a person may assist.

Due to how close we are to Election Day, some existing forms will need to be used even though they include language that no longer applies. Do not require individuals assisting voters to check off any boxes on any forms, including those on absentee ballots and absentee ballot envelopes, indicating their relationship to the voters or how many voters they have assisted. However, nothing prevents you from requiring persons assisting voters to identify themselves, as required by O.C.G.A. § 21-2-409(a).

Attached to this OEB is a notice regarding providing assistance to voters. This attached notice titled "Notice on Assistance" must be posted at all polling places in a location that is viewable at the major entrance of each polling place, effective immediately.

Also attached is a copy of the consent order.

ELECTION DAY

Voter enters the Polling Place

Accommodating Voters with Disabilities

Signs are vital. Directional signs should designate accessible parking spaces and be visible, especially those designating handicapped parking spaces, as well as the nearest accessible entrance if it is not the main door.

If the polling place does not have a permanent handicapped parking space, designate a handicapped parking space by placement of a temporary "Handicapped Parking Sign." Make sure there is wheelchair access to the building, the polling place, and the voting booth.

Always be courteous and respectful. Be considerate of extra time it may take for a person who is disabled or elderly to complete the voting process, and give unhurried attention to a person who has difficulty speaking.

Always speak directly to the voter, and not to a companion, aide, or sign language interpreter.

Animals that assist people with disabilities should be admitted into all buildings. DO NOT pet or distract these Assistance Animals, as they are working animals, not pets.

If you observe a voter with a disability who needs assistance, ASK "May I help you in any way?" before rendering assistance. The answer you receive should dictate any further assistance.

Place chairs or benches along a waiting area for the convenience and comfort of those who may have difficulty standing in line.

Assistance to Voters

A voter is entitled to assistance if the voter is:

- Unable to read the English Language and/or
- Has a disability which renders the voter unable to:
 - See or mark the ballot...OR
 - Operate the voting equipment...OR
 - Enter the voting compartment or booth without assistance
- Notice of the availability of assistance shall be posted at polling place.
- "A physically disabled or illiterate elector may receive assistance in preparing his or her ballot from" ...
- Any person of the elector's choice EXCEPT
 - Elector's Employer or Agent of Employer
 - Officer or Agent of Elector's Union
 - Candidate on the Ballot or Family Member of Candidate
 - Unless Disabled/Illiterate Elector is Related to Candidate

No person whose name appears on the ballot as a candidate at a particular election nor the mother, father, grandparent, aunt, uncle, sister, brother, spouse, son, daughter, niece, nephew, grandchild, son-in-law, daughter-in-law, mother-in-law, father-in-law, brother-in-law, or sister-in-law of that candidate shall offer assistance during that particular election under the provisions of this Code section to any voter who is not related to such candidate. For the purposes of this subsection, "related to such candidate" shall mean the candidate's mother, father, grandparent, aunt, uncle, sister, brother, spouse, son, daughter, niece, nephew, grandchild, son-in-law, daughter-in-law, mother-in-law, father-in-law, brother-in-law, or sister-in-law. § 21-2-592. Failure of poll officers to keep record of assisted voters

For the purposes of this subsection, the term "related to such candidate" shall mean such candidate's mother, father, grandparent, aunt, uncle, sister, brother, spouse, son, daughter, niece, nephew, grandchild, son-in-law, daughter-in-law, mother-in-law, father-in-law, brother-in-law, or sister-in-law. The person rendering assistance to the elector in preparing the ballot shall sign the oath printed on the same envelope as the oath to be signed by the elector. Any person who willfully violates this subsection shall be guilty of a felony and, upon conviction thereof, shall be sentenced to imprisonment for not less than one nor more than ten years or to pay a fine not to exceed \$100,000.00, or both, for each such violation.

Notice of the provisions of this Code section shall be prominently displayed in the registrar's office or absentee ballot clerk's office.

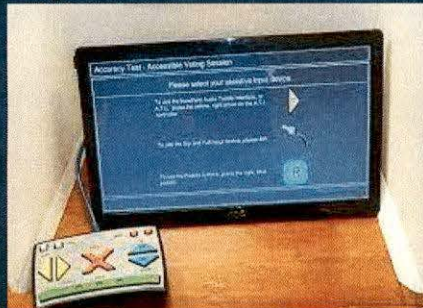

Intent to Process or Tabulate Early for the _____ Election

O.C.G.A. § 21-2-386(a)(3) - A county election superintendent may, in his or her discretion, after 7:00 A.M. on the day of the primary, election, or runoff open the inner envelopes in accordance with the procedures prescribed in this subsection and begin tabulating the absentee ballots. If the county election superintendent chooses to open the inner envelopes and begin tabulating such ballots prior to the close of the polls on the day of the primary, election, or runoff, the superintendent shall notify in writing, at least seven days prior to the primary, election, or runoff, the Secretary of State of the superintendent's intent to begin the absentee ballot tabulation prior to the close of the polls. The county executive committee or, if there is no organized county executive committee, the state executive committee of each political party and political body having candidates whose names appear on the ballot for such election in such county shall have the right to designate two persons and each independent and nonpartisan candidate whose name appears on the ballot for such election in such county shall have the right to designate one person to act as monitors for such process. In the event that the only issue to be voted upon in an election is a referendum question, the superintendent shall also notify in writing the chief judge of the superior court of the county who shall appoint two electors of the county to monitor such process.

The county superintendent shall be permitted to designate locations where monitors and public observers may view the process and may do so in a way that does not interfere with election officials. The superintendent may make reasonable regulations, including social distancing measures and required personal protective equipment, that designated monitors and observers shall follow so that they do not interfere in any way with the processing of ballots or the conduct of the election.
