For the open records request attached, our office has did not identify any responsive records for **Request #1**; therefore, we do not have responsive records.

In accordance with O.C.G.A. § 50-18-71(c)(1), **the estimated cost for retrieving, reviewing, and redacting the identified records is \$38.** Because the cost estimate is more than \$25.00, agreement to pay the estimated charges is required prior to conducting the search. The estimated cost and time does not include the first fifteen minutes, which are without charge and were used to conduct an initial search of our records.

In light of earlier open records requests received and the ongoing processing of such requests, the responsive, **redacted records are estimated to be ready for production in 30 business days from our office's receipt of your acceptance of charges. Charges must be accepted within 7 business days or the request will be deemed abandoned and pre-payment must be received within 30 days or the request will be deemed abandoned**
