Election Investigation Update



Many questions have been raised about the November election that expose weaknesses and faults in our current election system. I previously announced a top-to-bottom investigation, but it appears it will take longer than initially anticipated and will require more manpower to complete.

To restore full integrity and trust in elections, we have decided to change direction. On Friday, I named Justice Gableman as Special Counsel and gave him additional authority and independence to hire more full-time investigators who will work at his direction.

After talking with our original investigative team, we realized that the part-time nature of these contracts would not allow for the amount of time needed to complete the investigation. Justice Gableman will have the resources and ability to determine the need for any future adjustments.

Through this investigation, we aim to ensure there is confidence that every vote will be counted and laws concerning future elections will be faithfully and uniformly followed.

We hope to complete this thorough investigation in the fall and review the findings at the same time we receive results from the nonpartisan Legislative Audit Bureau, which is currently conducting a statewide, multi-faceted forensic audit.

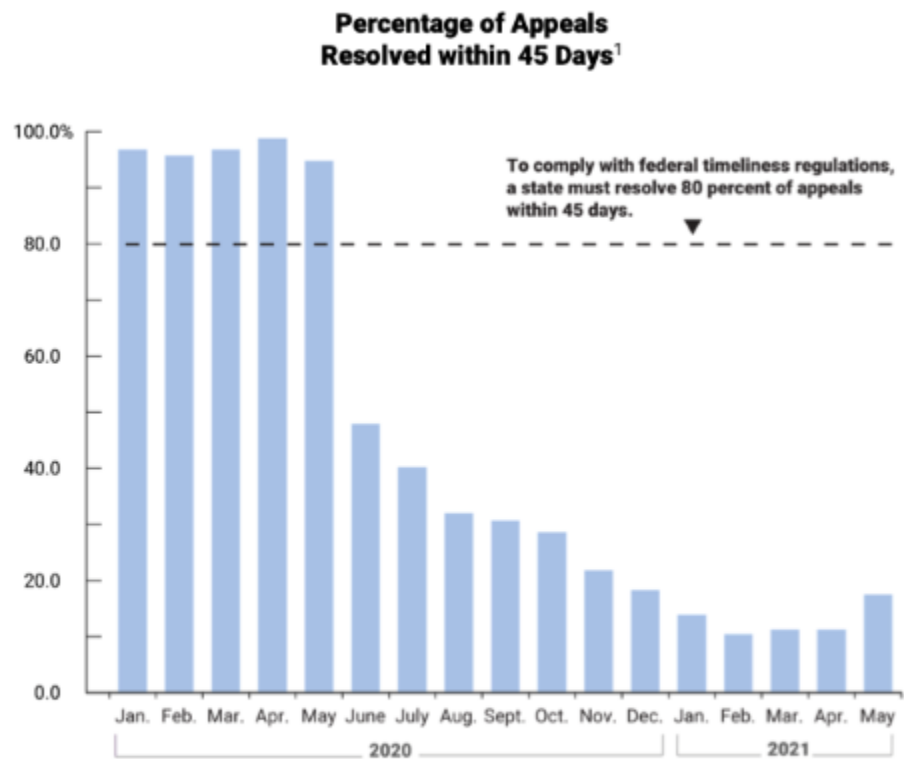
Unemployment Insurance Program

The governor's handling of Wisconsin's Unemployment Insurance program continues to be a disaster. The nonpartisan [Legislative Audit Bureau](#) (LAB) released a [report](#) showing the Wisconsin Department of Workforce Development (DWD) is still mismanaging the program. The LAB found the department "did not comply with federal regulations to issue appeal decisions in a timely manner from June 2020 through May 2021."

The federal government requires at least 80% of a state's unemployment appeal decisions be made within 45 days of receiving the appeal. LAB found that only 17.5% of DWD's decisions made in May 2021 were made within 45 days of receiving the requests. The usual excuse from the administration is to blame the outdated computer system for discrepancies, but the failure to be in compliance with these deadlines has nothing to do with the software. In addition to the LAB audit, Republican members of the state's congressional delegation asked Governor Evers and his administration for an accounting of how federal dollars were being used for the Unemployment Insurance program. The request was sent back in May, but they have yet to receive a response. Last week, they issued a new [request](#) for the administration to provide details on how the unprecedented amount of federal funding being sent to Wisconsin is helping the

state's unemployed.

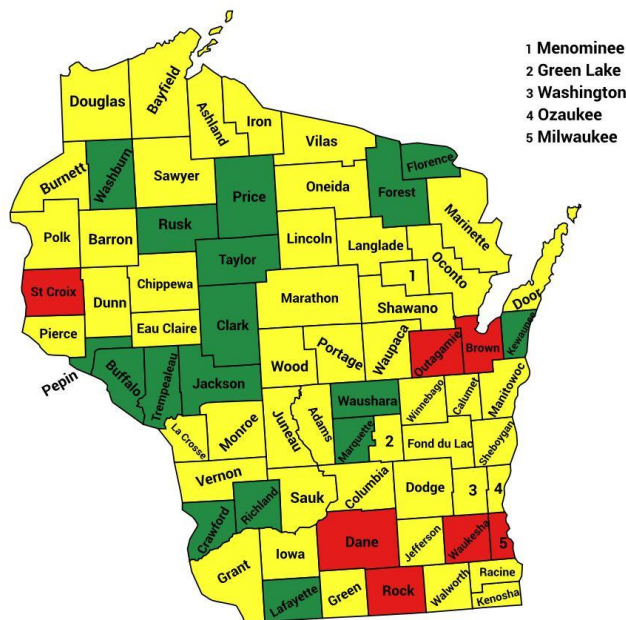

Dear Rep. Sanfelippo,

Under the state's Public Records Law (§§19.31-39, Wisconsin Statutes), I request electronic records of any and all citizen correspondence, including phone calls, received by you beginning on January 20, 2021 and up to and including Aug. 15, 2021 that mention election fraud, an election audit, and/or voting irregularities. If you have already trashed these public records, please retrieve them and send them to me electronically.

My purpose is to tally citizens' opinions; therefore, I need original messages and notes of phone messages, not merely the contact count. I want this correspondence regardless of whether you consider the contact to be your constituent.

Electronic records can be attached to an email, saved to a CD or flash drive and mailed, or uploaded to a private link you will send me that can be deactivated as soon as I've downloaded the records.

I refer you to The Wisconsin Institute for Law and Liberty (WILL) which in concert with four other groups filed [an amicus brief in the case of Lueders v Krug](#). Lueders' suit was decided in favor of electronic records in [Dane County Circuit Court](#) and unanimously confirmed by the [Court of Appeals](#) on June 5, 2019. You are legally required to fulfill this request with electronic records only.

Please also be aware that the Public Records law "shall be construed in every instance with the presumption of complete public access consistent with the conduct of governmental business. The denial of access generally is contrary to the public interest and only in exceptional cases can access be denied."

Because I specifically request to receive these public records electronically, I expect there will be no charges.

The law requires you to respond to this request "as soon as practicable and without delay." Per Wis. Stat. §19.33, you are the legal custodian of the records specified herein and bear the responsibility of that response.

I look forward to hearing from you. Thank you.

Election Investigation Update



Many questions have been raised about the November election that expose weaknesses and faults in our current election system. I previously announced a top-to-bottom investigation, but it appears it will take longer than initially anticipated and will require more manpower to complete.

To restore full integrity and trust in elections, we have decided to change direction. On Friday, I named Justice Gableman as Special Counsel and gave him additional authority and independence to hire more full-time investigators who will work at his direction.

After talking with our original investigative team, we realized that the part-time nature of these contracts would not allow for the amount of time needed to complete the investigation. Justice Gableman will have the resources and ability to determine the need for any future adjustments.

Through this investigation, we aim to ensure there is confidence that every vote will be counted and laws concerning future elections will be faithfully and uniformly followed.

We hope to complete this thorough investigation in the fall and review the findings

at the same time we receive results from the nonpartisan Legislative Audit Bureau, which is currently conducting a statewide, multi-faceted forensic audit.

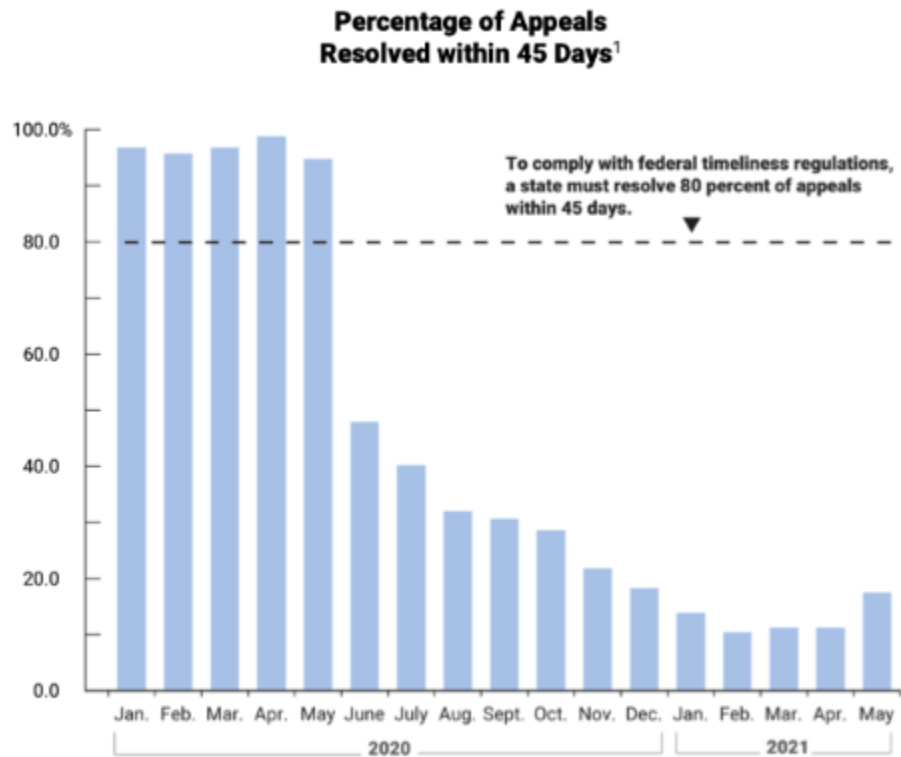
Unemployment Insurance Program

The governor's handling of Wisconsin's Unemployment Insurance program continues to be a disaster. The nonpartisan [Legislative Audit Bureau](#) (LAB) released a [report](#) showing the Wisconsin Department of Workforce Development (DWD) is still mismanaging the program. The LAB found the department "did not comply with federal regulations to issue appeal decisions in a timely manner from June 2020 through May 2021."

The federal government requires at least 80% of a state's unemployment appeal decisions be made within 45 days of receiving the appeal. LAB found that only 17.5% of DWD's decisions made in May 2021 were made within 45 days of receiving the requests. The usual excuse from the administration is to blame the outdated computer system for discrepancies, but the failure to be in compliance with these deadlines has nothing to do with the software. In addition to the LAB audit, Republican members of the state's congressional delegation asked Governor Evers and his administration for an accounting of how federal dollars were being used for the Unemployment Insurance program. The request was sent back in May, but they have yet to receive a response. Last week, they issued a new [request](#) for the administration to provide details on how the unprecedented amount of federal funding being sent to Wisconsin is helping the

state's unemployed.

Thanks for contacting my office regarding an election audit.

We are taking a two-pronged approach to review the integrity of our voting process here in WI.

First, we ordered our Legislative Audit Bureau to conduct an extensive audit (*some people use the term forensic audit*) of the 2020 election looking for evidence of wrongdoing. You can find the scope of the audit here:

Second, the Assembly Campaigns and Elections Committee (*of which I am Vice Chairman*) is conducting an extensive investigation to determine the extent of proper enforcement and adherence to our election laws. The investigation is being coordinated by former Justice Gableman and we have hired a team of private investigators. At my insistence, under this investigation the committee has been given seldom-used powers in the legislature that allow us to issue and enforce subpoenas compelling individuals to cooperate with the investigation. It should be noted that Speaker Vos has been extremely supportive of and directly involved with on this important matter.

Because our committee's investigation is quite detailed and extensive, I expect that it would take the remainder of this year before our final report is complete. I fully intend to hold anyone

accountable to the maximum extent of the law who is proven through this investigation to have willfully or knowingly broken our election laws.

Dear Rep. Sanfelippo,

Under the state's Public Records Law (§§19.31-39, Wisconsin Statutes), I request electronic records of any and all citizen correspondence, including phone calls, received by you beginning on January 20, 2021 and up to and including Aug. 15, 2021 that mention election fraud, an election audit, and/or voting irregularities. If you have already trashed these public records, please retrieve them and send them to me electronically.

My purpose is to tally citizens' opinions; therefore, I need original messages and notes of phone messages, not merely the contact count. I want this correspondence regardless of whether you consider the contact to be your constituent.

Electronic records can be attached to an email, saved to a CD or flash drive and mailed, or uploaded to a private link you will send me that can be deactivated as soon as I've downloaded the records.

I refer you to The Wisconsin Institute for Law and Liberty (WILL) which in concert with four other groups filed [an amicus brief in the case of Lueders v Krug](#). Lueders' suit was decided in favor of electronic

records in [Dane County Circuit Court](#) and unanimously confirmed by the [Court of Appeals](#) on June 5, 2019. You are legally required to fulfill this request with electronic records only.

Please also be aware that the Public Records law “shall be construed in every instance with the presumption of complete public access consistent with the conduct of governmental business. The denial of access generally is contrary to the public interest and only in exceptional cases can access be denied.”

Because I specifically request to receive these public records electronically, I expect there will be no charges.

The law requires you to respond to this request “as soon as practicable and without delay.” Per Wis. Stat. §19.33, you are the legal custodian of the records specified herein and bear the responsibility of that response.

I look forward to hearing from you. Thank you.

Given the information that has been reported this week on the 2020 election for Georgia and for Arizona, the following is a reasonable request:

Rep. Ramthun:

“After reviewing the information released from both the Fulton County audit in Georgia and today’s Arizona Senate hearing on the Maricopa County audit, I am formally requesting a more comprehensive audit from former Justice Michael J. Gableman and the Legislative Audit Bureau into the 2020 presidential election in Wisconsin.

- 1) I demand that a full forensic audit of the state-wide 2020 election be started immediately, using the Arizona audit plan as a model.
- 2) I demand that the delegation from Wisconsin sent to Arizona confirm how a transparent, secure, and proper audit is accomplished & duplicate what they learned here.
- 3) I demand the laws of the State of Wisconsin be followed and enforced. Any amount of voter or election fraud is unacceptable. A secure election does not include outsiders running and influencing our elections with legal consequences for all those who break the law.

You need to restore voter confidence in Wisconsin by doing a complete and full forensic audit of the 2020 election, be part of the solution in restoring the citizens trust in elections and government.

Re: Public Records Law Request

Dear Representative Sanfelippo:

Pursuant to Wisconsin's public records law, Wis. Stat. §§ 19.31–19.39, American Oversight makes the following request for copies of records.

On May 26, 2021, Wisconsin State Assembly Speaker Robin Vos indicated that the legislature would hire three former law enforcement officers and a supervising attorney to investigate the November 2020 election.¹ Since the time of this announcement, the names of several of the contracted individuals have been made public, including former Milwaukee Police Detective Mike Sandvick and former Wisconsin Supreme Court Justice Michael Gableman, whose past actions have raised concerns over the partiality of the investigation.²

On July 26, Representative Brandtjen announced that the Assembly Campaign and Elections Committee intended to “initiate a more intensive investigation” of alleged

fraud,³ separate from that overseen by Assembly Speaker Robin Vos,⁴ and issued subpoenas to Milwaukee and Brown Counties for election materials the following week.⁵ On July 30, Speaker Vos announced that two investigators had quit due to time demands and former justice Gableman would instead serve as “special counsel” in an expansion of the original investigation.⁶ Many details remain obscure regarding the inquiries announced by Speaker Vos and Representative Brandtjen, including when contractors’ terms commenced and/or ended, and whether or to what extent the two investigations will intersect or overlap.

American Oversight seeks records with the potential to shed light on the Wisconsin legislature’s investigations of the November 2020 election.

Requested Records

American Oversight requests that your office produce the following records “as soon as practicable and without delay”:⁷

All records reflecting communications (including emails, email attachments, text messages, messages on messaging platforms (such as Slack, GChat or Google Hangouts, Lync, Skype, or WhatsApp), telephone call logs, calendar invitations, calendar entries, meeting notices, meeting agendas, informational material, draft legislation, talking points, any handwritten or electronic notes taken during any oral communications, summaries of any oral communications, or other materials) sent or received by Representative Joe Sanfelippo, or anyone communicating on his behalf, such as a scheduler or assistant, or by his chief of staff regarding any investigations of the 2020 election.

This request should be interpreted to include, but not be limited to:

1. Communications with contracted investigators (including, but not limited to, Mike Sandvick and Steve Page) and former justice Michael Gableman, now designated Special Counsel, as well as with any individuals or entities contracted following the investigation’s expansion⁸
2. Communications with any contractors, subcontractors, counsel, consultants, formal or informal advisors, temporary workers, or volunteers associated with

- any investigations, or communications regarding the procurement of those individuals or entities
3. Communications with advocacy groups, external fundraisers, representatives of political parties, or news media regarding the investigation
 4. Communications regarding any proposed interim or final work products associated with any investigations, or actions to be taken based on any findings
 5. Communications regarding the Assembly's authorization of any investigations or the legal basis of any investigations
 6. Communications regarding the scope and conduct of any investigations, including, but not limited to, the potential or actual use of subpoena power⁹ or referrals to prosecutors
 7. Communications regarding the selection and evaluation of contractors
 8. Communications regarding the underlying premise of any investigation, including, but not limited to suspected or alleged fraud, misconduct, or irregularities
 9. Communications regarding the expansion of the investigation overseen by Speaker Vos and its relation to the investigation announced by Rep. Brandtjen on July 26¹⁰
 10. Communications regarding the statement issued by former President Trump accusing Speaker Vos and other Wisconsin officials of concealing "election corruption" and the subsequent call for Speaker Vos's resignation¹¹
 11. Communications between members or agents of the Wisconsin Legislature and former President Trump or his intermediaries
 12. Communications regarding potential or actual election investigations in other states, including, but not limited to, efforts in Arizona, Michigan, Pennsylvania, and Texas

Please note that American Oversight does not seek, and that this request specifically excludes, the initial mailing of news clips or other mass-distribution emails.

However, subsequent communications forwarding such emails are responsive to this request. In other words, for example, if Rep. Sanfelippo received a mass-distribution news clip email referencing the relevant statement by the president, that initial email would not be responsive to this request. However, if Rep. Sanfelippo forwarded that email to another individual with their own commentary, that subsequent message would be responsive to this request and should be produced.

Please provide all responsive records from July 15, 2021, through the date the search is conducted.

For all portions of this request, this request should be interpreted to include records pertaining to the investigation announced by Speaker Vos on May 26, the expansion announced by Speaker Vos on July 30, the investigation announced by Representative Brandtjen on July 26, and any other investigations by the Assembly into any matters related to the 2020 election. Please note that this request seeks

records in addition to, and not duplicative of, the records sought by any previous requests submitted by American Oversight.

Fee Waiver Request

In accordance with Wis. Stat. § 19.35(3)(e), American Oversight respectfully requests that the records be produced without charge. Providing American Oversight with a waiver of fees is in the “public interest” because American Oversight will, in accordance with its organizational mission, make the records available to the public without charge. These disclosures will likely contribute to a better understanding of relevant government action by the general public.

American Oversight’s work is aimed solely at serving the public interest. As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight’s financial interest. Rather, American Oversight’s mission is to serve the public by promoting transparency in government, educating the public about government activities, and ensuring the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media.¹² American Oversight also makes materials it gathers available on its public website¹³ and promotes their availability on social media platforms, such as Facebook and Twitter.¹⁴

The public has a significant interest in the Wisconsin state legislature’s investigations of the November 2020 election.¹⁵ Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including whether or to what extent partisan motivations or external actors guided the decision to open investigations or expand the scope of existing investigations. American Oversight is committed to transparency and makes the responses agencies provide to public records requests publicly available, and the public’s

understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

In conducting your search, please understand the term "record" in its broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions. Our request includes any attachments to these records. **No category of material should be omitted from search, collection, and production.**

Please search all locations and systems likely to have responsive records regarding official business. **You may not exclude searches of files or emails in the personal custody of your officials, such as personal email accounts.** Emails conducting government business sent or received on the personal account of the authority's officer or employee constitutes a record for purposes of Wisconsin's public records laws.¹⁶

In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records.¹⁷ If it is your position that a document contains non-exempt segments, but that those non-exempt segments are so dispersed throughout the document as to make segregation impossible, please state what portion of the document is non-exempt, and how the material is dispersed throughout the document. If a request is denied in whole, please state specifically that it is not reasonable to segregate portions of the record for release.

American Oversight expects that you have ensured all responsive records and records relevant to this request and your compliance with it are retained as required by Wisconsin law. Please take all appropriate steps to ensure that no such records are deleted by the agency before the completion of processing for this request. If records potentially responsive or relevant to this request, or your compliance with it, are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
