TWO GREAT UPDATES FOR OUR STATE

If you have been watching the news over the 4th of July weekend, you will have heard that Joe Biden intends to send people door-to-door to encourage people who have yet to get the jab, to get the jab, This raises many questions such as: How do they know who has or has not been vaccinated? Have my privacy rights been violated? What right do they have to make medical decisions for me? What happens if I don't comply- will I be assimilated?

Our state attorney general, Mark Brnovich, has taken action. He published a letter that he wrote to Biden stating that "I, along with many Arizonians, was greatly alarmed by your White House indicating that it might be in possession of medical records revealing the contact information for Americans who have not been vaccinated. BASELESS ETHICS CLAIM DISMISSED BY ETHICS COMMITTEE

WASHINGTON D.C. - Representative Paul A. Gosar, D.D.S (AZ-04), issued the following statement in response to the House Committee on Ethics decision to dismiss the baseless complaint filed against him by Representative Pramila Jayapal (WA-07).

“This patently baseless claim attempted to conflate political disagreements with ethics. The House Committee on Ethics should not be politicized for partisan purposes,” **stated Congressman Gosar.**

Background:

On March 10, 2021, in spite of evidence to the contrary, Representative Jayapal filed an ethics complaint against Congressman Gosar alleging that Congressman Gosar’s actions on January 6, 2021, particularly in objecting to the seating of electors, violated one or more rules of ethics. Indeed, Representative Jayapal ignored her own objection in 2017 to the seating of electors for President Trump in the filing of her 2021 complaint. On June 11, 2021, the House Committee on Ethics rejected the Jayapal Complaint.

Congressman Gosar contended that taking political disagreements and re-framing them as ethics violations is improper, unethical and fully lacking in decorum.

Gosar Introduces Separation of Powers Restoration Act

WASHINGTON, D.C. – Congressman Paul A. Gosar, D.D.S. (AZ-04) issued the following statement after introducing the Separation of Powers Restoration Act, legislation that restores the Constitution’s basic principal of dividing the federal government into separate branches with independent powers.

“For too long, the executive branch regardless of political party has developed an unbridled concentration of power never envisioned by the Founding Fathers. From forever wars and endless executive orders to overreaching emergency declarations, the executive branch has greatly weakened our system of checks and balances against one branch of government by exerting greater influence than the others.

My common sense legislation would restore the separation of powers and rein in an over-reaching executive branch as established by the Constitution,” **said Rep. Paul Gosar.**

Original Cosponsors: Rep. Thomas Massie (KY-04), Rep. Marjorie Taylor Greene (GA-14).

Background:

The separation of powers is a doctrine of constitutional law under which the federal government is separated into the executive, legislative and judicial branches. Each branch has separate powers and one branch is not allowed to exercise the powers of the other branches. Congress writes the laws, the executive branch enforces the laws.

The Separation of Powers Restoration Act repeals the War Powers Resolution Act, terminates all states of emergency, reinvests national emergency declaration authority in Congress, blocks all Presidential orders unless it is the President acting with express authority granted in the Constitution or given by an Act of Congress, and gives members of Congress, state and local governments, and the People, standing to challenge Presidential orders in court which exceed executive power.

GOSAR VOTES TO END FOREVER WAR AUTHORITY

WASHINGTON, D.C. - Congressman Paul Gosar (R-AZ), issued the following statement after voting in favor of H.R. 256, a bill that repealed the authorization to use military force (AUMF) in Iraq that was initially passed by Congress in 2002, predicated on misrepresentations by the State Department about weapons of mass destruction. The vote passed 268-161.

Congressman Gosar stated, “It is unprecedented, and should never happen again, where the United States’ military has an almost 20-year authorization for war. Our military should be used to effectively neutralize enemies quickly, and then return to the home base. There was no reason to keep our troops in harm’s way for a generation, long after the active military campaign had ended. I look forward to ending additional authorizations of force that should have been terminated years ago. An America First military policy means military action to defend our homeland, and only for as long as is necessary. It does not mean setting up an occupying army or wasting billions of dollars “rebuilding” foreign countries or worse, attempting to impose Jeffersonian democracy on cultures and lands that do not share those values.”

Background: H.R. 256 was sponsored by California Democrat Representative Barbara Lee, who initially voted against this AUMF in 2002.

Massive Leadership and Security Failures Do Not Deserve Medals

WASHINGTON D.C. - Congressman Paul A. Gosar, D.D.S. (R-AZ), issued the following statement after voting NO on H.R. 3325, a bill to award four congressional gold medals to the United States Capitol Police and those who were present at the U.S. Capitol on January 6, 2021.

“What happened on January 6th was an unmitigated security failure. American taxpayers pay billions of dollars for security of the United States Capitol complex. Unfortunately, that security system completely failed on January 6th. In particular, political leadership, beginning with Speaker Nancy Pelosi, failed the rank-and-file police officers because they were not given the security support needed that day--in spite of advance warnings.

There were many instances of security failures on January 6, 2021. Don't take my word for it. CNN reported the following on June 8, 2021:

"Two Senate committees on Tuesday released the most comprehensive government report on the security failures leading up to the US Capitol insurrection on January 6, revealing new details about unheeded warnings, critical miscommunications and intelligence shortcomings. Congressional investigators pored through "thousands of documents," received written statements from 50 police officers who defended the Capitol and received testimony from a wide array of current and former officials who played a role in the security preparations and response."

The bipartisan report, over 128 pages, details an endless number of security failures. Security is not an easy task. Reasonable people understand that mistakes will be made when systems are run by humans. That being said, I could not support legislation to hand out medals for an event that Congress concluded all "entities responsible for securing and protecting the Capitol Complex and everyone onsite that day were not prepared for a large-scale attack, despite being aware of the potential for violence targeting the Capitol," **concluded Congressman Gosar.**

REP. BOEBERT INTRODUCES COMPREHENSIVE BILL TO PREVENT CATASTROPHIC WILDFIRES

Today, Rep. Lauren Boebert led 16 of her colleagues in introducing the [Active Forest Management, Wildfire Prevention and Community Protection Act](#), to improve the health of our nation's forests, remove bark beetle-killed trees, protect property, stop frivolous litigation, and prevent catastrophic wildfires.

Rep. Lauren Boebert stated: "44 large wildfires are currently burning more than 660,000 acres because of decades of poor forest management, radical environmental lawsuits, federal bureaucracy, and an emphasis on funding for suppression as opposed to active management. I introduced the strongest forestry bill in decades, and my Active Forest Management, Wildfire Prevention and Community Protection Act will fully fund the removal of trees killed by bark beetles, reform costly litigation processes used by radical enviros to halt responsible forest thinning, and assist rural communities by ensuring 25% of the revenues from logging in National Forests stay on the ground in counties that actively maintain their forests. This bill is fully paid for and will bring in billions for the U.S. Treasury. Instead of pandering to radical enviros, my bill puts rural communities first."



Chairman of the Western Caucus Dan Newhouse said, "I am deeply concerned about the increasing frequency and severity of wildfires in the Pacific Northwest and across the rural West. As Chairman of the Congressional Western Caucus, I am committed to addressing this issue and am proud to stand with Rep. Boebert in support of this common-sense legislation. Allowing for active forest management will help prevent catastrophic wildfires, protect our local communities, and improve the health of our nation's forests."

Representative John Carter stated: "Unfortunately, the country has witnessed the insurmountable devastation caused by wildfires across the nation, but with a more proactive approach, we can greatly reduce these catastrophes. I'm proud to join Representative Boebert on the Active Forest Management, Wildfire Prevention and Community Protection Act to implement targeted forestry management techniques that will improve the health of our forests and protect communities against destructive wildfires."

Congressman Pete Sessions said, "As an Eagle Scout, I understand the importance of conserving the outdoors. We have seen the catastrophic damage caused by wildfires, particularly in California and Colorado. This bill will provide safety and stability to communities and increase the health of our nation's forests."

Representative Matt Rosendale stated: "Year after year wildfires ravage the west in large part due to a lack of proper forest management on federal lands. I am proud to be an original cosponsor of the Wildfire Prevention and Community Protection Act, which will be transformative in promoting active forest management and mitigating the risk of catastrophic wildfires. This commonsense bill is fully paid for and is a win-win for the taxpayers of Montana, and the nation."

Representative Tom Cole stated: "Over the past several years, wildfires have devastated communities nationwide. Not only do these destructive fires cause untold damage to the environment, they claim hundreds of lives. In response to this situation, I am proud to co-sponsor the Active Forest Management, Wildfire Prevention and Community Protection Act. This legislation offers commonsense solutions for preventing wildfires as well as reducing lumber prices by rehabilitating the health of our forests."

Congressman Tom Tiffany said, "The forest products industry is a key economic driver in Wisconsin's 7th District. This bill provides proactive solutions to many of the challenges our nation's forests face and will allow for active forest management to restore forest health and reduce the threat of catastrophic wildfires."

American Loggers Council Executive Director Scott Dane said, "The American Loggers Council strongly supports Congresswoman Boebert's Forestry Bill. This bill takes a comprehensive approach to addressing and mitigating the factors impeding healthy forest management and wildfire suppression. I recently participated in a six-hour helicopter survey of the aftermath of the million acres of wildfire destruction in California. From that vantage point the magnitude and scope was beyond description. Adding to the impression was the urgent private land timber salvage operations in contrast to minimal public land salvage and reforestation efforts. Unfortunately, with the current conditions the west is poised to experience a repeat of the previous years. It is time to take an all of the above approach to improving

the health of our forests and reducing the negative environmental consequences, property losses and fatalities created by severe wildfires.”

Louisiana Forestry Association Executive Director C.A. “Buck” Vandersteen said, “The Louisiana Forestry Association commends Representative Boebert and her colleagues for addressing opportunities to actively manage forests, prevent insect and disease, reduce the threat of wildfire and produce an income stream to accomplish the task. It is past time to act but with Representative Boebert and her colleagues’ vision and perseverance, the nation can begin to accomplish great things for its forests.”

Background:

In 2020, the U.S. set a new record as 57,000 wildfires caused 10.3 million acres to go up in flames. Rep. Boebert’s district has already experienced five large wildfires this year, and nationally, there are currently 44 large active wildfires.

The bark beetle epidemic has infected all 8 of the national forests in the Rocky Mountain Region and has destroyed 45 million acres of forest including 15 million acres of Forest Service land. Bark beetles kill trees and turn them into fuel for wildfires—creating dangerous conditions throughout the West. Rep. Boebert’s Active Forest Management, Wildfire Prevention and Community Protection Act creates the Western Bark Beetle Epidemic Fund to remove dead beetle trees and reduce the risk of wildfire. This fund is fully paid for by the increases in receipts that will result from increased timber harvests authorized by the bill.

To prevent wildfires and protect critical infrastructure, Rep. Boebert’s bill authorizes the removal of hazard trees within 500 feet of electric power lines. This removes unnecessary bureaucracy and is a commonsense reform that will protect critical infrastructure and grid reliability for rural communities.

Rep. Boebert’s bill puts communities first by designating counties containing National Forest Service land as Forest Revenue Areas. Counties in Forest Revenue Areas will receive 25% of the revenue generated from timber harvests. Additionally, Rep. Boebert’s bill includes provisions that guarantee that PILT payments and Secure Rural Schools payments are not negatively impacted by the additional Forest Revenue Area payments. These additional revenues will allow rural communities to fund law enforcement, search and rescue operations, infrastructure, schools, and other essential services.

Rep. Boebert’s bill also includes litigation reforms that will prevent frivolous litigation and prevent environmental extremists from blocking hazardous fuels reduction and active management projects. These projects will boost rural economies and make our forests healthier and more sustainable for years to come.

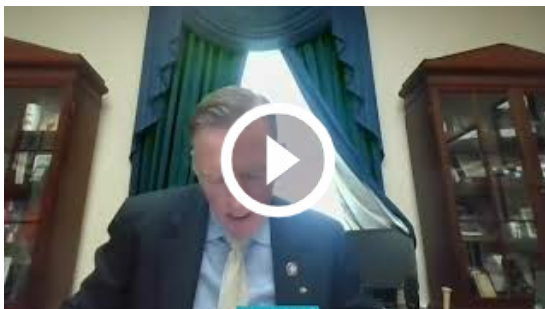

Who Killed Ashli Babbitt?

PRESCOTT, AZ - Representative Paul A. Gosar, D.D.S. (AZ-04) issued the following statement in remembrance of Ashli Babbitt, who was killed in the United States Capitol on January 6, 2021.

“Six months ago today, Ashli Babbitt, a 110-pound woman with nothing in her hands, not a rock, not a stick or a bat, was shot dead by a still unknown Capitol Hill police officer. Her death has been ruled a homicide. Yet, we have very little information about her death. Our fake news media has asked no questions or sought information about this tragedy. So, I have. And now President Trump has joined me in seeking the truth.

In many instances, when a law enforcement officer kills an individual for any reason, that officer’s name is publicly released. There is then an investigation and the public is given updates, briefings and ultimately a copy of the investigation. But not in the case of Ashli Babbitt. Instead, there is a determined effort to cover up the full circumstances of this homicide and the American people won’t stand for it.

Why won’t the Department of Justice identify the shooter? Why won’t the Department of Justice release the nearly 14,000 hours of surveillance video taken on January 6? I have asked for this for months. Why haven’t the SWAT team members standing by Ashli at the moment of her murder been interrogated and their statements released? They were right next to her and saw no threat. Certainly, no lethal threat. Why were there no warnings given or escalation of command and force in proper law enforcement technique? Why have no charges been brought against the shooter for negligent homicide or more?

It is unjust to sweep Ashli’s death under the rug by merely saying she was in the wrong place at the wrong time, as so many have. Her life mattered. We do not allow the execution of citizens by street “justice” in our country. We have rejected vigilantism and police abuse for generations.

Ashli’s family and the American people deserve to know the truth about her death. A fair investigation is needed, and this cannot just be hidden from public scrutiny. Transparency is critical for the public to accept the conclusions. I will not stop my quest to find answers to who killed Ashli Babbitt,” **said Rep. Gosar.**

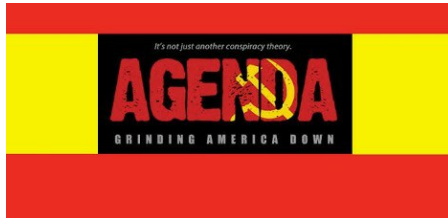

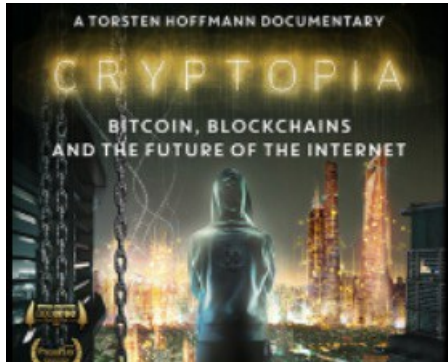
