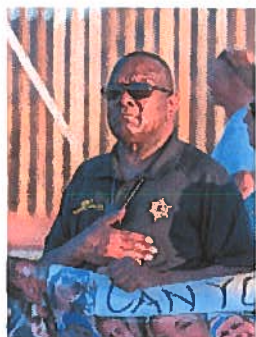

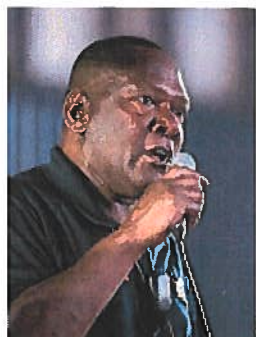

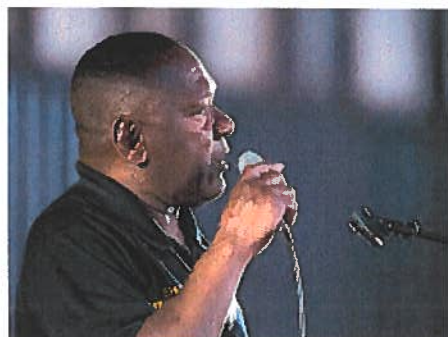

Good morning Sheriff Childress! I had previously discussed this with Chief Hamilton but wanted to run this by you. I represent the Livingston County Mental Health Board and we receive tax levy funds that are then distributed to agencies and programs in our County that support people with mental health, developmental disabilities, and substance use issues. About a year ago, I heard about a program in the suburbs called HERO (Heroin Epidemic Relief Organization) and they have constructed semi-truck trailer (named "Hidden in Plain Sight") to present a youth's bedroom and how drugs, alcohol, and paraphernalia can be hidden. The trailer is available to communities for events. I originally had the trailer booked for 2020 Harvest Days in Dwight, but with the Pandemic, everything was cancelled. I do have them book to come to our Harvest Days in Dwight on Saturday for several hours and be located downtown in a specified area. The Mental Health Board will pay the donation to the organization and I am reaching out to all of the agencies and departments throughout Dwight and also the County, asking for their support in our PR. In the PR, I would like to list the various departments that are supporting this endeavor to show our community that we are all behind the fight against drugs! Can I use the Livingston County Sheriff's Department in the wording?
