WE ARE RATHER PROUD that Mollie Hemmingway's recently published book "Rigged" aligns with what we have been claiming for over a year now that the WI-5 mayors and their staffs were running an illegal GOTV campaign using Zuckerberg money directed toward the minority community which ultimately generated votes for Biden. And with everyday that passes, we are finding more and more evidence that, not only were they running this illegal GOTV campaign, **but clerks enabled left-leaning operatives to have access to the WEC WisVote system.**

With a minimum of training (an hour or so), someone with access to WisVote could register voters, have access to poll books and all information to run an election. To gain access to the system, a user must have a username and password, a FIDO key, and an applet downloaded to the machine they are using to access the database. There are four levels of entry to WisVote, Clerk, Data Entry, WEDC Entry and Read Only entry. If you have a crooked clerk, providing absentee ballots, envelopes and access, a nefarious actor could actually go out, register a voter, help the person vote and act as the witness for the voter. Based on information we have collected thus far, we believe that is exactly what was happening. These actors would then deposit the vote in one of the handily placed ballot drop boxes that Zuckerberg paid for.

Many people have been asking questions concerning our investigation, what do we have, to prove that civil laws were broken and how.
