This letter is in response to your Freedom of Information Act (FOIA) request dated 12/22/2021 to the Executive Office for Immigration Review (EOIR) in which you seek Email correspondence/calendars (CAIJ/CIJ).

On January 11, 2022, EOIR sent a partial response pertaining to item 3 of your request. On March 8, 2022, EOIR provided you with another partial response pertaining to item 2 of the request and placing item 1 your request on hold.

On April 8, 2022, EOIR provided you two spreadsheets with the search results for Judge Wetmore and Judge Short's emails. On April 21, 2022, you provided a list of emails that you were interested. On June 8, 2022, you confirmed the final list of emails to be processed by EOIR to satisfy item 1 of your request.

Accordingly, we are granting partial access to the responsive record(s). Also, upon review of the records, it was determined that there are records originated from different agencies. Those records have been forwarded to the Office of Information Policy and the Department of Homeland Security for a release determination and direct response to you. Accordingly, EOIR has closed this request.

Additionally, portions of the enclosed records have been redacted in accordance with FOIA Exemption 5, 5 U.S.C. § 552(b)(5), which concerns certain inter- and intra-agency communications protected by the deliberative process privilege.

Additionally, portions of the enclosed records have been redacted in accordance with FOIA Exemption 6, 5 U.S.C. § 552(b)(6), which concerns material the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties.

Additionally, portions of the enclosed records have been redacted in accordance with FOIA Exemption 7(C), 5 U.S.C. § 552 (b)(7)(C), which allows for withholding of information compiled for law enforcement purposes the release of which could reasonably be expected to constitute an unwarranted invasion of personal privacy.

Finally, portions of the enclosed records have been redacted in accordance with FOIA Exemption 7E, 5 U.S.C. § 552(b)(7)(E), which concerns records or information compiled for law enforcement purposes the release of which would disclose techniques and procedures for law enforcement investigations or prosecutions. FOIA Exemption 7E extends protection of information related to agency technology systems. *See Levinthal v. FEC*, 219 F.Supp.3d 1, 9 (D.D.C. 2016).

Please be advised that we have considered the foreseeable harm standard when reviewing records and applying FOIA exemptions.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist. *See* <http://www.justice.gov/oip/foiapost/2012foiapost9.html>.
