This letter describes the April 13, 2021 production from the U.S. Department of the Treasury (Treasury) in the above-referenced Freedom of Information Act (FOIA) litigation.

As explained our production transmittal letter dated February 25, 2021, Treasury produced 145 pages of the 187 pages determined to be responsive to the McConnell Communications request. Of the remaining 42 responsive pages, Treasury is producing 8 pages today. Portions of the pages produced have been withheld pursuant to FOIA Exemption 6. The other 34 pages of responsive records have been referred externally for consultation. Treasury will produce those records, as appropriate, once those consultations have concluded.
