This is the electronic final response to your Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS), dated July 19, 2019, and received by this office on July 31, 2019. You are seeking all records reflecting communications between (a) political appointees* in the Department of Homeland Security (DHS) Office of Legislative Affairs, Office of General Counsel, or DHS Leadership Offices and (b) any of the White House Counsel staff listed below regarding congressional oversight of the executive branch—including both specific congressional oversight of specific matters and general policies, concerns, and considerations related to congressional oversight of the executive branch: Brittany Biles, Richard Cleary, John Coghlan, Christopher Cook, Melissa Croslow, Elizabeth Gorman, Chase Harrington, Elizabeth Horning, Mark Lytle, Coreen Mao, Austin Mayron, Brian Miller, Michael Purpura, Brian Rabbitt, Mackenzie Siebert, and Jeffrey Freeland (Date Range for Record Search: From 9/1/2018 to 7/19/2019).

We conducted a comprehensive search of files within the Office for the Chief Information Officer (OCIO) for records that would be responsive to your request. Unfortunately, we were unable to locate or identify any responsive records.

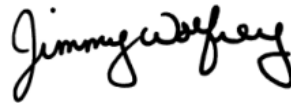
While an adequate search was conducted, you have the right to appeal this determination that no records exist within OCIO that would be responsive to your request. Should you wish to do so, you must send your appeal and a copy of this letter, within 90 days of the date of this letter, to: Privacy Office, Attn: FOIA Appeals, U.S. Department of Homeland Security, 2707 Martin Luther King Jr. Avenue, SE, Mail Stop 0655, Washington, D.C. 20528-0655, following the procedures outlined in the DHS FOIA regulations at 6 C.F.R. Part 5 § 5.5(e)(2). Your envelope and letter should be marked "FOIA Appeal." Copies of the FOIA and DHS FOIA regulations are available at www.dhs.gov/foia.

Additionally, you have a right to right to seek dispute resolution services from the Office of Government Information Services (OGIS) which mediates disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. If you are requesting access to your own records (which is considered a Privacy Act request), you should know that OGIS does not have the authority to handle requests made under the Privacy Act of 1974.
