Dear Ms. Sloan:

This is in response to your July 23, 2019, request submitted to the Department of State (the Department) pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, in which you requested “All email communications sent by U.S. ambassador to Israel David Friedman, or anyone communicating on his behalf, containing terms “Trump Heights” or “Ramat Trump” from March 1, 2019 through the date the search is conducted. The Department conducted a search and located 44 pages that are responsive to your request. After careful review, we determined that those pages are appropriate for release in part. All released material is enclosed. The withheld information is exempt pursuant to:

- 5 U.S.C. § 552(b)(5), which concerns certain inter- and intra-agency communications protected by the deliberative process privilege; and
- 5 U.S.C. § 552(b)(6), which concerns material the release of which would constitute a clearly unwarranted invasion of an individual’s personal privacy.

Where applicable, the Department has considered the foreseeable harm standard when reviewing this record and applying FOIA exemptions. This action closes your request in this office. Please include the case tracking number cited above in all communications concerning this request.

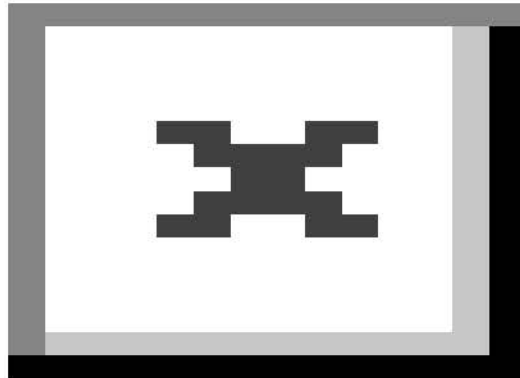

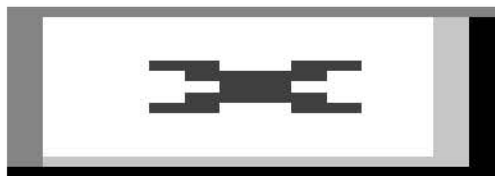

לקחי הגולן

מאת דוד פרידמן, שגריר ארה"ב בישראל

ביום ראשון, 16 ביוני, היתה לי הזכות להיות מוזמן לישיבת קבינט של ממשלת ישראל. הישיבה, שכונסה בשדה פתוח ברמת הגולן, באוויר הרים צלול ובנוף מרהיב, עסקה בנושא אחד בלבד: הצעת החלטה לאשר הקמת יישוב חדש באתר הזה, תחת השם "רמת טראמפ".

ההחלטה התקבלה פה אחד. זו היתה הפעם הראשונה מאז הארי טרומן (1949) שיישוב ישראלי נקרא על שם נשיא אמריקאי מכהן. ההחלטה היתה מחווה הולמת להחלטתו האמיצה והנועזת של הנשיא להכיר בריבונות הישראלית על רמת הגולן.

רבים בירכו על ההצהרה רבת-החשיבות של הנשיא טראמפ מ-21 במרס, 2019, ובמקביל מלות ביקורת בקעו מהמקומות הקבועים. אך לאחר שהרעש נדם והשמש שקעה ואז זרחה מחדש, שתי אמיתות נותרו בולטות ללא עוררין: מעמדה של ארצות הברית בעולם עלה, וביטחונה של ישראל התחזק. עתה, חודשים ספורים לאחר מכן, אני מתבונן אחורה בכמה מהלקחים שהפקנו:

1. מדיניות חוץ חייבת להשתנות בהתאם לנסיבות המשתנות. רבים אשר ביקרו את החלטתו של הנשיא ציינו כי ראש הממשלה יצחק רבין זכרונו לברכה ניהל מגעים עם חאפז אל-אסד ב-1994, על החזרת חלקים מרמת הגולן בתמורה לשלום, וקראו לא לסגור את הגולל על התהליך הכושל הזה. זאת, למרות שכמעט אף לא אחת מהנסיבות ששררו אז רלבנטיות למצב היום. מלחמת האזרחים בסוריה, שבמהלכה יותר ממיליון סורים נרצחו או נעקרו מבתיהם, היתה מאורע רב-השפעה שחייב להסתיים בויתור סורי על תביעתה, שהיתה רפה מלכתחילה, לשטחי רמת הגולן.
2. שכל בלי אומץ יוצר מדיניות חוץ חלשה. כל הנשיאים הינם חכמים. אלמלא היו חכמים, לא היו מצליחים להיבחר לעמדותיהם הרמות. כל נשיאי העבר הבינו את הצורך של ישראל להחזיק בריבונות על רמת הגולן. אך רק לנשיא טראמפ היה האומץ להוציא את האמת הבלתי מעורערת הזאת אל הפועל. זו חשיבותו של האומץ.
3. צדק יוצר עוצמה. היו מי שמתחו ביקורת על החלטתו של הנשיא וטענו כי היא דוגמה להנחה המוטעית שמעצמה חזקה כמו ארצות הברית יכולה לנקוט מדיניות נעדרת בסיס מוסרי. אבל במקרה הזה, ההפך הוא הנכון: ארצות הברית חזקה יותר, מאחר שנהגה בצורה צודקת. ארצות הברית תמכה בישראל, אומה שלמרות הסיכונים, פתחה מדי לילה את גבולה כדי לספק סיוע חירום רפואי לאזרחים סורים חולים ופצועים, אל מול הממשלה הסורית שגרמה סבל בל יתואר לעמה.
4. לא כל החלטה במדיניות החוץ מחייבת מידה כנגד מידה. יש מי שטוען שאמריקה "היתה צריכה לקבל דבר-מה מישראל" בתמורה להכרתה בריבונות על רמת הגולן.

אך עוצמתה של ההחלטה האמריקאית נובעת מהיותה נעוצה בחוק ובמוסר, ולא מזהמת במשא ומתן היומיומי המוכר לעייפה בעולם היחסים הבינלאומיים.

5. אל תתחילו מלחמה שאתם לא יכולים להרשות לעצמכם להפסיד בה. סוריה תקפה באגרסיביות את ישראל ב-1967 ואחר כך שוב ב-1973. העובדה שאיבדה את שליטתה ברמת הגולן קשורה ישירות למפלותיה במלחמות הכושלות האלה.

ההיסטוריה תזכור בחיוב את הכרתו של הנשיא טראמפ בריבונות הישראלית על רמת הגולן. יש לקוות שהלקח שנלמד מההחלטה יוצאת מן הכלל זו תשפיע על מדיניות החוץ של מנהיגים בעולם, על מנת ליצור עולם צודק, שלו והומאני יותר.
