This is the final response to your Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS), dated September 26, 2019, and received by this office on September 30, 2019.

You are seeking:

1. all email communications (including email messages, email attachments, and calendar invitations) relating to any proposal to release detainees in sanctuary cities, including by bussing them to such cities, involving any person at the White House Office (including anyone with an email address ending in @who.eop.gov)
2. all email communications (including email messages, email attachments, and calendar invitations) relating to any proposal to release detainees in sanctuary cities, including by bussing them to such cities, sent by any of the officials specified below to any email address ending in .com, .org, .edu, .net, or .mail. American Oversight requests that DHS produce the responsive records of the following officials:

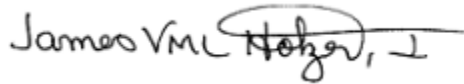
We conducted a comprehensive search of files within the Department of Homeland Security's, Office of the Chief Information Officer (OCIO) for records that would be responsive to your request. Unfortunately, we were unable to locate or identify any responsive records.

While an adequate search was conducted, you have the right to appeal this determination that no records exist within Department of Homeland Security's, Office of the Chief Information Officer (OCIO) that would be responsive to your request. Should you wish to do so, you must send your appeal and a copy of this letter, within 90 days of the date of this letter, to: Privacy Office, Attn: FOIA Appeals, U.S. Department of Homeland Security, 245 Murray Lane, SW, Mail Stop 0655, Washington, D.C. 20528-0655, following the procedures outlined in the DHS FOIA regulations at 6 C.F.R. Part 5 § 5.8. Your envelope and letter should be marked "FOIA Appeal." Copies of the FOIA and DHS FOIA regulations are available at www.dhs.gov/foia.

If you need any further assistance or would like to discuss any aspect of your request, please contact the analyst below who processed your request and refer to **2019-HQFO-01279**. Additionally, you have a right to right to seek dispute resolution services from the Office of Government Information Services (OGIS) which mediates disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. If you are requesting access to your own records (which is considered a Privacy Act request), you should know that OGIS does not have the authority to handle requests made under the Privacy Act of 1974.
