We refer you to our letter dated December 21, 2021, regarding the release of certain Department of State material under the Freedom of Information Act (the "FOIA"), 5 U.S.C. § 552. Upon further review, the Department has determined that additional information may be released in 13 documents previously released in part.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made excisions, the applicable exemptions are marked on each document. All nonexempt material that is reasonably segregable from the exempt material has been released.
