Re: Advance Voting in City of Atlanta and City of Hapeville elections

Dear Rick,

This letter is to confirm our conversation on February 14, 2019 regarding advance voting for the two municipal special elections that the Fulton County Board of Registration and Elections has contracted to conduct for the City of Atlanta and the City of Hapeville on March 19, 2019.

Published news reports earlier this week indicated that there were no plans to conduct any advance voting for these two elections, prompting my call to you on February 13, 2019. In that conversation I brought up O.C.G.A. § 21-2-385(d)(1)(A):

*"There shall be a period of advance voting that shall commence:
On the fourth Monday immediately prior to each primary or election;"*

O.C.G.A. § 21-2-2(5) makes clear that "election" includes both general and special elections. When we spoke on February 14, 2019, you confirmed that your staff had researched the matter further and were now offering advance voting for both elections to begin at the proper date, Monday, February 25, 2019.

I appreciate your prompt follow up and response on this issue.

Ralph, Rick, and Blake,

I got the attached mock-up from USPS for a redesign of the precinct card.

USPS said there just wasn't enough room on the current card to fit everything in a way that would work well with their machinery and software, so they are proposing a perforated, two-card solution. The detachable part would allow the voter to update their address, and the part the voter would retain would rearrange the data on the card as shown.

Obviously, this is a first whack at it, but I'm interested in your reactions to the proposal?

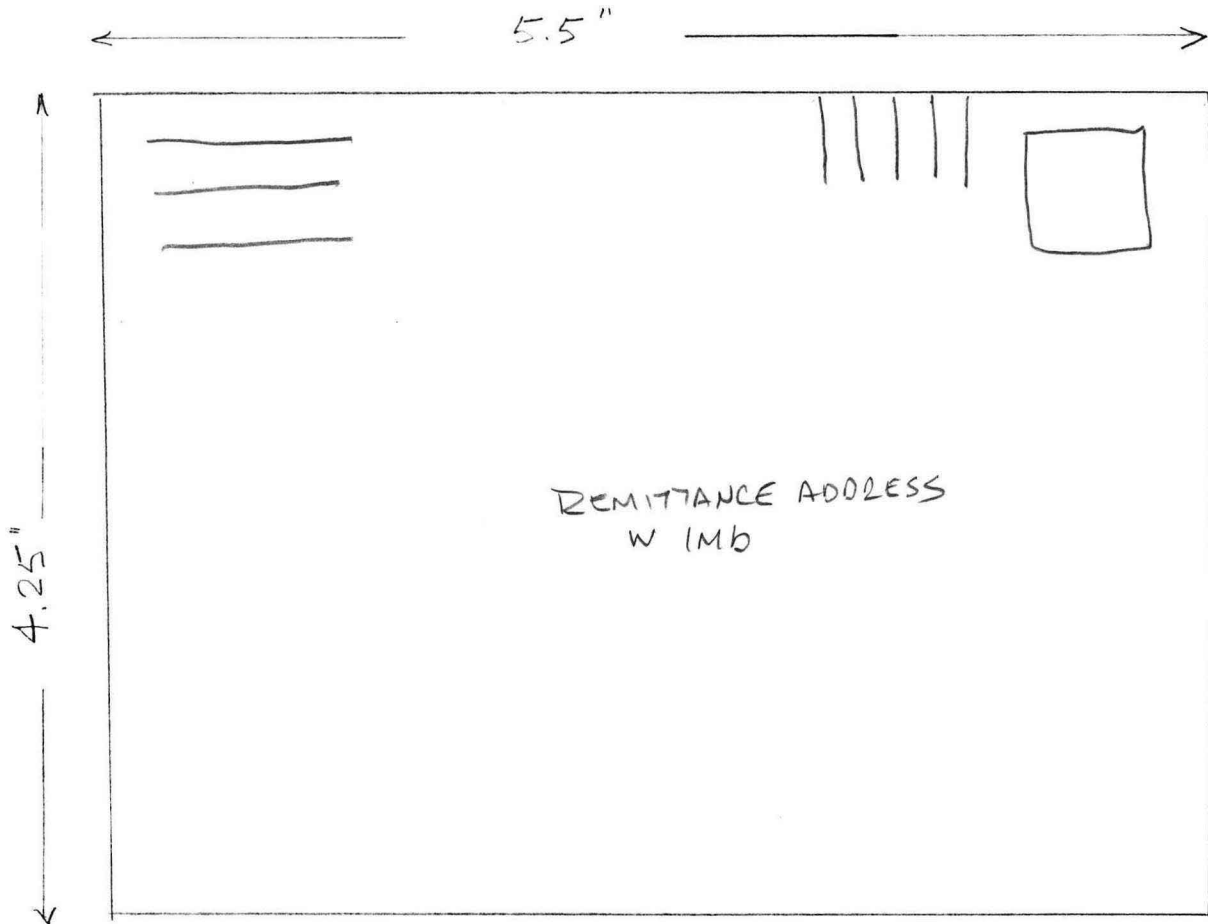

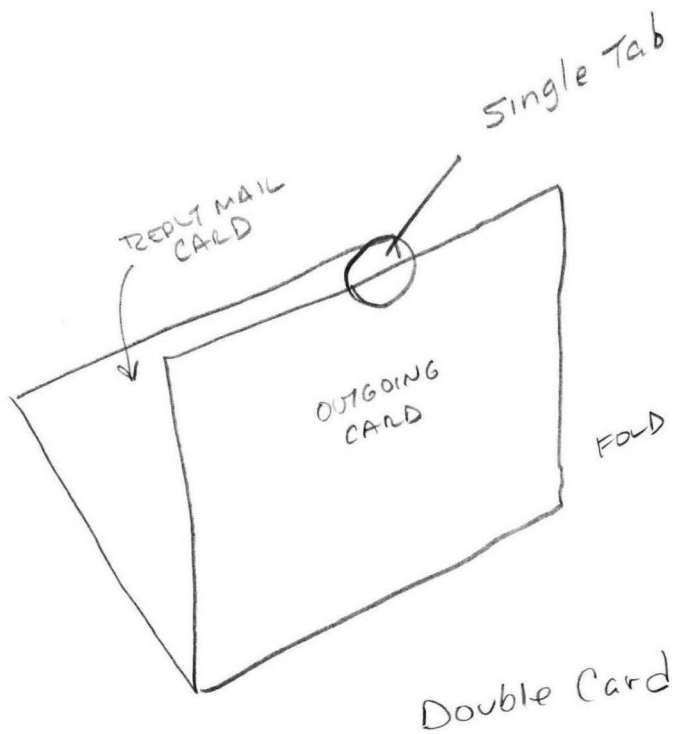

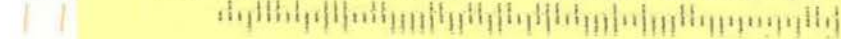
