This is the final response to your Freedom of Information Act (FOIA) request to the Department of Homeland Security (DHS), dated November 8, 2019, and received by this office on December 12, 2019.

Francis Cissna, former USCIS Director; Craig Symons, former Chief Counsel; anyone serving in the limited to the email address capacity of Chief Counsel; Jennifer Higgins, Associate Director for Refugee, Asylum, and International Operations; John Lafferty, Asylum Division; Robert Law, Senior Policy Advisor; Kathy Nuebel Kovarik, Chief of the Office of Policy and Strategy; Kaitlin Vogt Stoddard, former Advisor and Deputy Chief of Staff; John Zadrozny; and anyone serving in the capacity of White House Liaison or Advisor.

We conducted a comprehensive search of files within the Department of Homeland Security, Office of the Chief Information Officer (OCIO) for records that would be responsive to your request. Unfortunately, we were unable to locate or identify any responsive records.

While an adequate search was conducted, you have the right to appeal this determination that no records exist within Department of Homeland Security, Office of the Chief Information Officer (OCIO) that would be responsive to your request. 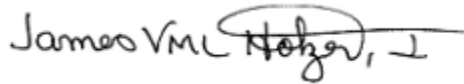

Additionally, you have a right to right to seek dispute resolution services from the Office of Government Information Services (OGIS) which mediates disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation. If you are requesting access to your own records (which is considered a Privacy Act request), you should know that OGIS does not have the authority to handle requests made under the Privacy Act of 1974.
