Dear Mr. Evers:

This is a final response to your November 19, 2019 Freedom of Information Act (FOIA) request, a copy of which is enclosed for your convenience. We received your request on November 19, 2019, and assigned it FOIA case number 20-F-0286. We ask that you use this number when referring to your request.

The Defense Human Resource Activity (DHRA), a component of the Office of the Secretary of Defense, conducted a search of their records systems. No records were identified as responsive to items one and two of your request. Please note that the Department of Defense does not have guidance, directives, instructions, policies, or procedures that relate explicitly to properties owned by the Trump organization, and there is no policy to recommend that its personnel patronize any specific hotel or restaurant. The enclosed documents, totaling three pages, were determined to be responsive to item three of your request. The Office of the Under Secretary of Defense for Personnel and Readiness (P&R), conducted a review of the three responsive pages. Ms. Jessica Levin, in her capacity as the P&R Initial Denial Authority has determined that portions of the three responsive pages are exempt from release pursuant to 5 U.S.C. § 552 (b)(6), as disclosure of the information would constitute a clearly unwarranted invasion of the personal privacy of individuals. Please note that we have considered the foreseeable harm standard when reviewing records and applying exemptions under the FOIA in the processing of this request.

In this instance, fees for processing your request were below the threshold for requiring payment. Please note that fees may be assessed on future requests.

SUBJECT: MEMORANDUM FOR RECORD

1. This memo documents that the Department of Defense determined that there was only one Government Purchase Card (GPC) transaction at a Trump-branded property from June 15, 2017, to July 26, 2019.
2. The transaction was in the amount of \$1,680, and paid for a meal provided for all traditional Guard individuals during the monthly inactive duty training for the New Jersey National Guard.
3. This transaction took place at Trump National Golf Club on December 2, 2017; a Government Purchase Card Program Manager for the National Guard Bureau stated that "documentation provided showed it appeared legitimate." He also stated that the Level 4 Agency Organization Program Coordinator for the Government Wide Purchase Program, National Guard Bureau came to the conclusion that "nothing improper had occurred."
4. This information is provided in response to questions-for-the-record submitted after a Senate Armed Services Committee hearing on July 16, 2019.
