This is in response to your January 7, 2020, request submitted pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, in which you requested unclassified communications between State officials and Congress between December 27, 2019, and January 7, 2020. The Department of State, Office of Information Programs and Services received your FOIA request on the same day, and assigned it tracking number F-2020-02765. Please be advised that a search was conducted in the department and 330 pages were located that are responsive to your request. After careful review, we determined that the records are appropriate for release in part and are exempt from disclosure in their entirety. All released material is enclosed. The denied information is exempt from release pursuant to:



This is one in a series of updates on Senator Cotton's work on the Banking Committee and on other economic policy. Please reply if you'd like to be removed from this; no offense will be taken, we all get too much email.

Looking ahead. This is an unusual month. The Senate is in session, the Cloakroom is open and bills can be introduced. But few hearings are scheduled as we await next steps on impeachment. To wit, the attached Senate 2020 calendar contains only 11 months, Feb-Dec. Impeachment is technically a piece of legislation, [H. Res. 755](#), which has passed the House but hasn't yet been 'transmitted' to the Senate. December's two big econ policy events were the SECURE Act finally [becoming](#) law and USMCA passing the House. Today the Senate Finance committee will [vote](#) on USMCA. That markup is one of only [six](#) Senate hearings this week, as 17 of 21 committees have none scheduled. *In theory*, the full Senate could pass USMCA this week.

- **Econ data.** This Friday we'll get the monthly jobs report, [expectations](#) are for +160K new jobs and unemployment to remain at a 50-year low of 3.5%. The Fed's Jan. 29 meeting [should](#) be a non-event. On Jan. 30 we get 4Q GDP, currently tracking around 2.3%. And if you're expecting a big refund, know that tax filing season [starts](#) Monday, Jan 27.

Senate Banking Committee. No hearings scheduled. We should note that Banking isn't one of the committees affected by newly sworn-in Georgia senator Kelly Loeffler, although she is replacing Sen. Perdue on the Ag committee (Perdue moves to Foreign Relations) and will [replace](#) Sen. Isakson on the Veterans and HELP committees. Fun fact: With Sen. Loeffler, there are now 34 senators who were born since the US has had 50 states (i.e. 66 senators were born before Hawaii became a state in August, 1959).

- **Cannabis banking.** Chairman Crapo released a 2200-word [statement](#) last month outlining his "significant concerns" with the House-passed SAFE Act. To be blunt, any cannabis bill [rolled out](#) by the Committee will be quite different from the SAFE Act. The Chairman's home state of Idaho is one of [three](#) states without any legal cannabis; the other two are SD & NE.

WeWork's Former CEO a "reason why so many Americans are skeptical of capitalism." See Sen. Cotton's Dec. 12 [appearance](#) on CNBC. This followed his [Q&A](#) with SEC Chairman Clayton and various [tweets](#) on the matter like "socialism causes poverty and misery everywhere it's tried. But if you want to know why it's popular, look no further than Adam Neumann & WeWork."



Other Notes:

- **ILLICIT CASH Act praised by religious groups, global NGOs and consumer banks.** More groups are publicly supporting Sen. Cotton's bipartisan AML reform bill. A group of 50+ religious groups and five major NGOs published letters last months, as did the Consumer Bankers Association.
- **House/Senate calendar.** Click here to view a combo House/Senate calendar. Note the mid-July break for the Dem convention in Milwaukee. The GOP convention in Charlotte occurs 8/24-27, during the normal August recess (although that July break reduces the August recess to four weeks).
- **Senators Cotton, Shaheen, Second Lady applaud law reforming occupational licensing for military spouses.** There's finally some good news on the often-counterproductive spread of state occupational licensing laws.
- **Bipartisan "live check" bill reintroduced.**
- **Trump nomination tracker.** Check out this summary of Trump nominees awaiting Senate confirmation.
- **Opportunity Zone regs released.** See Treasury's FAQ on the final OZ regulations. Plus there are incentives for OZ investments included in the FDIC/OCC proposed changes to the Community Reinvestment Act.
- **Cotton & colleagues introduce bills to clamp down on World Bank lending to China.** Also, Cotton & Schumer sent a letter urging President Trump to oppose China's efforts to lead the UN's Intellectual Property Organization.

Dear Chairman Crapo and Ranking Member Brown:

On behalf of the Consumer Bankers Association (CBA), we write to share our views regarding the Improving Laundering Laws and Increasing Comprehensive Information Tracking of Criminal Activity in Shell Holdings (ILLICIT CASH) Act, S. 2563. CBA is the voice of the retail banking industry; whose products and services provide access to credit for consumers and small businesses. Our members operate in all 50 states, serve more than 150 million Americans, and collectively hold two-thirds of the country's total depository assets.

CBA's members serve the critical function of monitoring, identifying and reporting suspicious activity to law enforcement, ensuring criminals do not access the American financial system to launder ill-gotten gains. Our members promote national security and deter financial crimes by committing significant resources towards the compliance of the Bank Secrecy Act (BSA), the USA PATRIOT Act, related anti-money laundering laws (AML) and the recently implemented FinCEN Customer Due Diligence (CDD) rule.

Criminal organizations that use shell companies with anonymous ownership structures to carry out their illegal activities should be stopped. CBA strongly supports and appreciates the efforts put forth by the group of eight bipartisan Senators to introduce this important piece of legislation that will modernize the AML/BSA infrastructure and encourage better communication between law enforcement, financial institutions, and regulators, and facilitating the adoption of modernized technologies.

We are pleased S. 2563 appropriately requires FinCEN – whose purpose is to safeguard the financial system, combat money laundering, and collect, analyze and disseminate financial intelligence – to collect and store beneficial ownership information of businesses when they are formed. A federal database of beneficial ownership information would provide transparency and enable financial institutions and law enforcement to search and rely on the government's information to more efficiently deploy resources in the fight against money laundering and terrorist financing. In addition, the ILLICIT CASH Act empowers Congress to update BSA/AML policies by giving the Treasury Department and law enforcement other tools needed to fight criminal networks.

CBA stands ready to work with Congress to improve corporate transparency, strengthen national security, and help law enforcement by modernizing the current BSA/AML regulatory regime.



Fact Sheet: Qassem Soleimani

- Since 1998, Qassem Soleimani commanded Iran's Islamic Revolutionary Guard Corps Qods Force (IRGC-QF), the terror arm of the Iranian regime. The IRGC-QF is tasked with planning and executing terror and military operations outside Iran's borders. Under Soleimani's command, the IRGC-QF has fueled destabilizing sectarian conflicts throughout the Middle East for decades.
- The IRGC-QF continues to wage an illegal campaign of terrorism, assassinations, and violence. At Soleimani's direction and with his oversight and guidance, the IRGC-QF has planned and conducted terrorist attacks across six continents and inside the United States.
- The United States designated IRGC-QF a Foreign Terrorist Organization for its activities, and designated Soleimani as a Specially-Designated Global Terrorist in 2011.
- As the leader of the IRGC-QF, Qassem Soleimani was directly responsible for arming, funding, and training proxy groups in Iraq, Syria, Lebanon, Bahrain, Yemen, Afghanistan, and elsewhere. Operations carried out by these proxy groups have led to the death and suffering of tens of thousands of innocent civilians. These proxies routinely target and kill civilians, intensify sectarian conflicts, and prolong the suffering of innocent men, women, and children.
- Soleimani personally directed and provided arms to militias in Iraq for more than a decade. These militias undermine the sovereignty of the Iraqi state, threaten the legitimacy of Iraq's security forces, and target American citizens and forces. With Soleimani's support and lethal assistance, proxies of the IRGC-QF targeted and killed over 600 Americans between 2003 and 2011.
- We can confirm that in the several days before his death, General Soleimani had been traveling in the Middle East coordinating further large-scale attacks against U.S. diplomats and service members. These threats were highly credible and the intelligence is sound. General Soleimani's travel also violated the ban imposed by the United Nations Security Council.
- Recent orders given by General Soleimani dramatically escalated Iran's campaign of violence and terrorism against U.S. citizens and interests in the Middle East. His actions culminated in Iranian-supported and equipped militias carrying out a series of attacks against American forces in Iraq over the past several months, including the rocket attack on December 27, 2019, which resulted in the death of an American citizen, wounded four American service members, and threatened the lives of many more American personnel. General Soleimani also ordered the assault on the U.S. Embassy in Baghdad.
- For his actions, Soleimani had been designated and sanctioned by the United Nations, European Union, and United States and is banned from international travel by United Nations Security Council Resolution 2231. However, Soleimani continued to travel to Iraq, Syria,

and Lebanon directing and coordinating lethal actions that pose a threat to regional peace and security, in defiance of United Nations Security Council resolutions.

- Some key international and United States designations of Soleimani include:
 - Designated a Tier I terrorist as part of the Department of State designation of the IRGC as a Foreign Terrorist Organization in 2019.
 - Designated under U.S. Executive Order 13224 as a Specially Designated Global Terrorist in 2011.
 - Designated under U.S. EO 13572 for human rights abuses in 2011.
 - Designated by the European Union in EU 442/2011 for support to the Syrian regime in 2011.
 - Designated under U.S. EO 13882 for providing material support to terrorists in 2007.
 - Sanctioned by the United Nations under UNSCR 1747 for involvement in Iran's nuclear program in 2007.

McConnell: "The Threat Iran Poses Is Not New"

'Wishing away tensions with Iran is not an option. The Iranians have spent decades making that clear. The question is whether we as a body would prefer the administration stand by as Iran kills Americans, or whether we're prepared to work with the president to stand up to Tehran's terrorism and shadow wars.'

WASHINGTON, D.C. – U.S. Senate Majority Leader Mitch McConnell (R-KY) delivered the following remarks today on the Senate floor regarding Iran:

'I spoke yesterday about President Trump's decision to remove the chief architect of Tehran's terrorism from the battlefield. And I discussed the Senate's obligation to approach this in a manner that is serious, sober, and factual.

'It is right for senators to want to learn more about the president's major decision. Once again, I encourage all our colleagues to attend the classified briefing which the administration will provide tomorrow.

'The Secretary of Defense, the Secretary of State, the Chairman of the Joint Chiefs of Staff, and the CIA Director will give classified context behind the president's decision. And they will discuss the administration's strategy to protect our personnel and defend our nation's interests in the new landscape.

'I would ask every senator on both sides to bring an open mind to this briefing.

'And in particular, we should all remember that the history of Iranian aggression began long, long before this news cycle or this presidency.

'In the decades since the Islamic Revolution of 1979, as the White House has changed parties and our administrations have changed strategies, Tehran's simmering anti-American hatred, proxy violence, and steady support for terrorism worldwide have remained entirely constant through all of these years.

'In effect, Iran has been at war with the United States for years. While they have taken pains to avoid direct conflict, Iran's authoritarian regime has shown no compunction about kidnapping, torturing, and killing Americans since its earliest days. Or Iraqis. Or fellow Iranians, for that matter.

'From the 52 diplomatic personnel held hostage in Tehran for 444 days back in 1979...

'To the hundreds of U.S. servicemembers killed in bombings carried out by Iran's proxies: Beirut in 1983, Riyadh in 1995, Khobar in 1996...

'To the hundreds more killed or maimed in Iraq by the explosives and indirect-fire attacks ordered by General Soleimani himself...

'To the constant flows of resources and equipment that prop up despots and terrorist organizations throughout the region...

'Iran's gameplan has been an open book: Use third-party terrorism to inflict death and suffering on its enemies while avoiding direct confrontation.

'The threat Iran poses is not new. Its violence is not some unique reaction to President Trump or Prime Minister Netanyahu or any other current leader. Violence runs in the bloodstream of this evil regime.

'In particular, our colleagues who apparently want to blame President Trump for Iranian provocative foreign policy should reflect on the recent history of the previous administration.

'Iran exploited President Obama's withdrawal from Iraq. Qassem Soleimani and his agents filled the void, dramatically expanding Iranian influence inside Iraq. They were able to impose a sectarian vision on Iraq that disenfranchised Sunnis, fueled the rise of ISIS, and plunged the region into chaos.

'And in Syria, more weakness from the Obama administration opened yet another door for Iran. The Democratic administration failed to confront the Iranian-backed Assad regime as it slaughtered literally hundreds of thousands of Syrians and displaced millions more. Once again, amid the chaos, Soleimani worked and thrived.

'Of course all of this was the backdrop for the brazen, legacy-shopping nuclear arrangement that sent billions of dollars to fuel Iran's further violence.

'Even my friend the current Democratic Leader knew it at the time. Before he himself voted for a resolution of disapproval on President Obama's deal, Senator Schumer said at that time, quote, *"after 10 years, if Iran is the same nation as it is today, we will be worse off with this agreement than without it."*

'The Democratic Leader was prescient. That is exactly what happened.

'The previous administration failed to confront Iran when necessary, so the mullahs used their windfall from the disastrous nuclear deal to double down on hegemonic aspirations across the Middle East.
