Dear Requester:

This is the third interim response to your Freedom of Information Act (FOIA) request, originally received by the United States Secret Service (Secret Service) on January 12, 2021, for information pertaining to:

1. All communications (including emails, email attachments, complete email chains, text messages (or messages on similar applications such as Signal or WhatsApp) and calendar invitations) sent or received by the officials listed below regarding events at the U.S. Capitol, U.S. National Mall, or surrounding grounds in Washington D.C. on January 6, 2021, including but not limited to the potential or actual deployment of law enforcement officers and/or National Guard troops, requests for assistance from members of Congress or Congressional staff, protests or armed activity at the Capitol, President Trump's rally, or concerns about security.

Please note that American Oversight does not seek, and that this request specifically excludes, the initial mailing of news clips or other mass-distribution emails. However, subsequent communications forwarding such emails are responsive to this request. In other words, for example, if a specified official received a mass-distribution news clip email referencing protests or violent activity at the Capitol, that initial email would not be responsive to this request. However, if a specified official forwarded that email to another individual with his own commentary, that subsequent message would be responsive to this request and should be produced.

2. All orders, directives, protocols, or guidance prepared, written, approved, or signed by the officials listed below, regarding events at the U.S. Capitol, U.S. National Mall, or surrounding grounds in Washington D.C. on January 6, 2021, including but not limited to the potential or actual deployment of law enforcement officers and/or National Guard troops, requests for assistance from

members of Congress or Congressional staff, protests or armed activity at the Capitol, President Trump's rally, or concerns about security.

## PLANNED DEMONSTRATIONS OF INTEREST (NCR): 8

1. From 11/19/20 to 01/31/21, daily, **Women for a Great America (NRID)** will host a demonstration at Lafayette Park. The purpose of the demonstration is to pray for a peaceful election. There is no indication of civil disobedience. The permit application indicates **50** expected participants.
2. On 01/05/21, at 9:00 AM to 01/12/21 at 9:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called, "**Protect the POTUS**" at the White House. The purpose of the event is to "protect President Trump from radical groups, like antifa or other bad actors who plan to take the White House." There is no indication of civil disobedience. According to Facebook, **3** people are going and **8** are interested.
3. From 01/05/20, at 10:00 PM to 01/07/21 at 10:00 AM, the individual (b)(6); (b)(7)(C) (NRID) will host an event called, "**FREE bus trip DC for the Jan 6 protest!**" in Washington, DC. The purpose of the event is to protest in support of President Trump. There is no indication of civil disobedience. According to Facebook, **14** people are going and **82** are interested.
4. From 01/06/21, at 9:00 AM to 01/07/21 at 12:00 PM, the individual (b)(6); (b)(7)(C) (NRID) will host a demonstration called, "**Patriot Protest March**" in Washington, DC. The purpose of the event is to "protest the election fraud, tyranny and corrupt politicians." There is no indication of civil disobedience. According to Facebook, **21** are going and **55** are interested.
5. On 01/08/21, at 12:00 PM, the group **Reed Justice Initiative (NRID)** will host a demonstration called, "**STOP FEDERAL EXECUTIONS**" at the Supreme Court. The purpose of this demonstration is to "demand justice for those who have been executed and stop federal executions." There is no indication of civil disobedience. The current numbers of planned participants are unavailable at this time.
6. On 01/09/21, from 2:45 PM - 4:30 PM, the group **Sindhi Foundation (RID)** will host a demonstration at the Embassy of Pakistan. The purpose of the event is to "bring awareness to human rights violations in Pakistan." There is no indication of civil disobedience. There are 30 participants listed on the permit application.  
  
**Sindhi Foundation** is of record for two embassy demonstrations in 2018 and 2020. The demonstrations concluded without arrests.
7. On 01/09/21, at an unknown time, an unknown group using email address **SilentMajorityTakeBack@gmail.com (NRID)** will host a demonstration called, "**The Take Back of Washington, DC.**" The group claims "we are coming, this time we are not leaving!" There is no mention of civil disobedience. The current number of planned participants are unavailable at this time.
8. Daily from 01/15/21 to 01/24/21, at an unknown time, the group **DC Action Lab (RID)** will host demonstrations at Columbus Circle, Freedom Plaza, Farragut Square, McPherson Square, Lincoln Memorial, on the National Mall between 3<sup>rd</sup> and 14<sup>th</sup> Streets, NW, Washington Monument grounds, JFK Hockey Fields, Constitution Gardens, Hains Point, MLK Memorial, Franklin Square, Lafayette Park, White House and Meridian Hill. The purpose of the event is "freedom of speech against the

inauguration.” There is no indication of civil disobedience. The permit application listed 5,000 participants.

**DC Action Lab** is of record for numerous white house demonstrations from 2013-2019. Some demonstrations have concluded with arrests.

The intent is to nail down a comprehensive timeline, staffing numbers and other details as quickly as possible. We would like to have a working draft by COB tomorrow.

(b)(6); (b)(7)(C) and (b)(6); (b)(7)(C) have the lead for this project. They will be reaching out today to begin coordination.

The final product will be provided to all directorates upon completion.

(b)(6); (b)(7)(C) stated he drove from Michigan with a letter outlining his concerns and proposed solutions for POTUS. (b)(6); (b)(7)(C) stated he has sent numerous emails and letters to POTUS, and this would be his last attempt at contact. After this attempt, the government can destroy itself. (b)(6); (b)(7)(C) stated he would travel next to see his mother in Delaware. At the conclusion of the interview, (b)(6); (b)(7)(C) left the area.
