Hi Emma,

Below is a description of the search DCNG conducted. Please let me know if you have some time next week to discuss how to proceed now in this matter.

DCNG does not maintain a system that includes call logs for calls made on its official telephones. DCNG did, however, request a manual review of the calendar entries of BG Aaron Dean, BG Mark Maldonado, and MG William Walker (Retired), but did not locate any records of telephone calls on January 6, 2021. In addition, DCNG submitted requests to personnel serving as the personal staff, at the time of January 6, 2021, of the DCNG custodians identified by Plaintiffs, to search for call logs and emails or calendar entries recording any telephone calls on January 6, 2021. DCNG received responsive documents from an Aide De Camp, which NGB produced to Plaintiff in February 2021.

Hope you're doing well! For Army, I believe we owed you a description of its search: Army requested the relevant call log data for the officials identified in the FOIA request on the specified date (JAN 6, 2021) from the Joint Service Provider (JSP), an office of the DOD. In response, JSP conducted a search to produce all call logs for desk phones in offices assigned to the Secretary of the Army, Under Secretary of the Army, Chief of Staff, Vice Chief of Staff, and Director of the Army Staff for the date, 6 January 2021, for multiple desk phones deployed in those offices. The logs produced in May 2021 provided in Army's response in this matter are the result of the foregoing search requested by the Army to JSP for the matter in litigation.

For DCNG, I believe we had passed along its final response (attached). Again, thank you for your understanding re: the confusion concerning the separate searches conducted by National Guard and then DCNG.

Please let me know if there's anything else outstanding.

Hi Emma,

I have passed your questions onto my clients, and have been conferring with them. Note that my principal contact with Army is away on paternity leave, so I have been a bit delayed on getting the Army-related information. On the search parameters for DOJ and National Guard Bureau:

**For DOJ**, OIP requested the relevant call data for the officials identified in the FOIA request officials on the specified date from the Office of the Chief Information Officer, Justice Management Division (“OCIO”). In response, OCIO provided OIP the data requested. In consultation with Plaintiff, OIP extracted and processed the “relevant data columns” from the call data while omitting the non-relevant data columns. The handwritten and typed logs provided in OIP’s final response in this matter were provided to OIP by knowledgeable staff in the Department’s Senior Management Offices in the course of OIP’s processing a separate request for records related to January 6, 2021.

**For the NGB**, the process for responding to the FOIA request was divided into two tracks. NGB handled the search for General Daniel Hokanson, Lieutenant General Marc Sasseville, Chief Master Sergeant Tony Whitehead, and Lieutenant General Jon Jenson. NGB directed the inquiries to the relevant offices; in particular, the Office of the Chief of the National Guard Bureau conducted a reasonable, internal search for call logs associated with Hokanson, Sasseville, and Whitehead. NGB produced phone records based on the searches to the Office of the Director of the Army National Guard and the Office of the Chief of National Guard Bureau, on July 11, 2021 and August 6, 2021, respectively. This included records for Jenson and Hokanson. NGB made a final production, one that contained DCNG equities, on February 17, 2022. I am attaching correspondence describing the relevant searches conducted, including one letter that I appear to have mistakenly failed to pass along in November. I apologize for that oversight.

The requests for phone records from Major General William Walker, Brigadier General Aaron Dean II, and Brigadier General Mark Maldonado were directed to the D.C. National Guard, as reflected in the attached correspondence sent to Plaintiff on March 2, 2021 (Transfer letter to requestor). Note that each of the 54 National Guard States, Territories, and the District of Columbia maintain their own respective computer servers, IT sections, phone equipment, etc., and any records from those three Service Members, be it computer records or call logs, would reside with the DCNG. NGB does not maintain direct custody or control over those records. We understand that those searches are still ongoing.

Regarding the searches, we are particularly concerned with the National Guard Bureau's productions. Of the seven custodians listed, we only received call logs from Gen. Hokanson (in addition to a handwritten timeline of events on January 6<sup>th</sup> from another unnamed custodian that mentions some calls made). Is the agency certain that it does not have any call logs from any of the other six listed custodians in this request?

Good morning Kuntal,

As we have a JSR due Friday, I wanted to send over a few outstanding questions American Oversight has regarding this case:

- Could Army, NGB, and DOJ please provide the parameters of the searches run for records responsive to American Oversight's requests?
- Productions from Army and DOD withhold all identifying information related to the identity of any caller under

Exemption 6 (for both) and Exemption 7(C) (for Army). American Oversight believes that a blanket withholding of every caller is overbroad. In order to justify these withholdings, the agencies must balance the individual's privacy interest with the public interest in disclosure. *Nat'l Archives & Records Admin. v. Favish*, 541 U.S. 157, 171 (2004). These requests concern the call logs of only high-ranking officials, each of whom has a diminished privacy interest due to their position. And the public interest in the activities of senior government officials on the day an attempted insurrection breached the Capitol is extraordinarily high. American Oversight requests that Army and DOD reconsider their withholdings under Exemptions 6 and 7(C).

I recognize that the agencies will not have time to respond by the time our JSR is due. I've attached a draft JSR – please let me know if you have any edits, or questions about the above inquiries.
