Dear Requester:

This letter is in response to your Freedom of Information Act (FOIA) request dated January 11, 2021 for all call logs from January 6, 2021 from the officials specified below:

1. General Daniel Hokanson, Chief, National Guard Bureau (NGB),
2. Lieutenant General Marc Sasseville, Vice Chief, NGB,
3. Chief Master Sergeant Tony Whitehead, Senior Enlisted Advisor, NGB, and
4. Lieutenant General Jon Jenson, Director, Army National Guard.

Your request was received by NGB on January 11, 2021 and assigned case #J-21-0057. On March 10, 2021 your office filed suit against NGB, prompting the closure of your request.

On July 9, 2021 this office provided an interim response to you through the Department of Justice (DoJ) for records responsive to item 4 of your request, concerning logs of General Jon Jenson, Director of the Army National Guard.

A search by the Office of the Chief of the National Guard Bureau revealed 1 page responsive to item 1 of your request. This office is providing a second interim response to you through DoJ for item 1 of your request. A portion of these records you have requested are being granted to you in part. After a thorough review of this document, our office determined that portions of it are exempt from disclosure under the FOIA, 5 U.S.C. § 552 (b)(6).

Exemption (b)(6) protects personnel, medical, and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. Under this exemption, I am withholding names of Department of Defense employees below the grade of General Officer and personal information on third parties.
