Dear Mr. McGrath:

This is the response of the Civil Division, Department of Justice to your Freedom of Information Act request for “all email communications (including emails, email attachments, complete email chains, calendar invitations, and calendar invitation attachments) sent by then Assistant Attorney General for the Civil Division Jody Hunt and that contain any of the following key terms: Von Bokern; Bokern; career position; career role; civil service; Burrow.” In addition, you requested “all email communications (including emails, email attachments, complete email chains, calendar invitations, and calendar invitation attachments) between then Assistant Attorney General for the Civil Division Jody Hunt and Jordan Von Bokern.” This Office received your request on March 1, 2021.

After a search of the Civil Division’s records, this Office could locate no responsive records subject to the FOIA in its files. Accordingly, this Office is closing your request at this time.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that we give to all our requesters. You should not take it as an indication that excluded records do, or do not, exist.

Your appeal must be postmarked or electronically transmitted within 90 days of the date of my response to your request. If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
