

It is Fake News. I was completely unaware that a group known as the Proud Boys were in attendance. I have no connections to this group and never plan to. In fact, at this time I had absolutely no idea who the Proud Boys were or what they represented. I was very proud to speak at the Red, White, and Blue Rally in support of the Marysville High School Football Seniors, and their family members who serve our country, and do not regret doing so. The purpose behind the event was to support the MHS Football Seniors’ family members who serve, Law Enforcement, First Responders, the United States Military, and the First Amendment to the United States Constitution.
