

Gentlemen:

I submit the following as public comment at your open meeting of January 11, 2021. I am a resident of The Hammock in Flagler County.

My purpose here is to seek the resignation of Joe Mullins from the County Commission. I urge the Commission to demand that Mullins resign immediately. This is because Mullins participated in and sponsored a trip of more than 160 locals to join the Washington, D.C. mob that ultimately stormed the U.S. Capitol on January 6. Mullins publicly embraces violence.

First, Mullins recently said on WNZF radio that he would like to “cut off” some “liberals’ heads.” Internet links to it have been removed, but it has been reported in the media. <https://flaglerlive.com/159936/mullins-beheading-liberals-pt/>

Next, Mullins joined with three busloads of people from Flagler and nearby counties to take a trip to disrupt Congress on January 6 at the march that became an insurrection. The contingent was organized by local group “Flagler Liberty Coalition” (FLC). FLC specifically directed participants to a now defunct website that reputedly fed the violence and insurrection called [WildProtest.com](https://flaglerlibertycoalition.com/flc-trip-to-dc-jan-1-2021/). <https://flaglerlibertycoalition.com/flc-trip-to-dc-jan-1-2021/>.

Despite claims of peaceful protest, Mullins and FLC publicly foreshadowed the violent mayhem in social media and local websites as follows:

- FLC issued invitations on its website and YouTube to join its bus trip, January 5-7, telling attendees that:
  - they *should* bring 3-inch knives, pepper spray and mace, helmets etc.;

- A video of the buses’ departure from the Fairgrounds shows:

- Also, on the FLC’s page are earlier videos of automatic rifle “Training Practice” followed by an announcement of the January 6. bus trip. # US Capitol breached: Volusia, Flagler reacts

Volusia and Flagler County residents were among the pro-Donald Trump protesters who marched to the U.S. Capitol Wednesday, but it was unclear whether any participated in storming the building.

Some of the Make America Great Again demonstrators broke into the Capitol, forcing a delay in Congress' certification of Joe Biden as winner of the presidential election, with members being evacuated.

Erika Benfield of DeBary was at the protest, listening to President Trump's speech decrying problems he had with the election — despite state and federal officials' repeated determinations that no widespread fraud had affected the outcome. She participated in the march that followed, describing it as "peaceful" when she got closest to the Capitol.

"At that point, there was barricades on either side, and I didn't see any violence at all," Benfield said. She didn't realize the Capitol had been breached until after she got back to her hotel.

"We were there because we wanted to witness history, wanted to hear directly from our elected leaders and wanted to participate in a friendly protest," she said, calling the situation that developed "sad."

Another among the crowd, Flagler County Commissioner Joe Mullins, posted on Facebook that he believes Donald Trump, loser of the 2020 election, should remain in office.

"There's easily 1 million-plus people here," Mullins said in a Facebook video. "This is for our kids and their future."

The Volusia County Republican Party Facebook page posted a photo of the

Elected officials, including Volusia and Flagler counties' congressman who was on the House floor when rioters at-

"This is despicable. This is not who we are as a country," U.S. Rep. Michael Waltz, a Republican Trump supporter

from St. Augustine Beach, told Fox News. "We were doing this through debate and discussion from our interpretation of the Constitution. ... There is no place for violence."

Volusia County Sheriff Mike Chitwood called on Trump to take a stand against the Capitol riot.

"What's occurring right now in DC is not democracy. It's un-American," Chitwood tweeted. "It is not free speech — quite frankly it's pure thuggery."

Volusia County Councilman Ben Johnson, the former sheriff, said he voted for Trump but believes the president is at least partially to blame for fanning the flames with claims of election fraud.

"This is a sad day in American history. Any time you have people like this take over the U.S. Capitol, to come in here and try to usurp our democracy, it's a sad day," Johnson said. "The man in charge should be telling people to stand down. That's not the way to do it."

Johnson said "there's always going to be some" issues with an election. "But is there a widespread conspiracy? No, I don't think so. ... This is almost like a coup and you can't have that."

Vic Baker, a Volusia County Republican Party state committeeman, pointed to a tweet from Trump calling for peace.

"There's pent-up frustration among the MAGA nation, no question about it," Baker said. "What we see is they're very frustrated, they're angry and their impatient."

Baker, who contends widespread fraud did affect the outcome of the election, concedes that Joe Biden will take the oath of office on Jan. 20. He also texted a message: "I personally condemn the use of violence to resolve constitutional disputes. This is not the appropriate way for American patriots to protest."

On December 6, the U.S. Treasury released new information for the new \$25 billion emergency rental assistance program authorized under the [year-end COVID-19 relief and omnibus spending package](#). Under the legislation, counties with populations above 200,000 residents are eligible to receive direct payments from the U.S. Treasury. Other counties may receive an allocation from their state, similar to original Coronavirus Relief Fund (CRF) program under the CARES Act.
