I hope you are doing well. Sorry it took me longer than expected to send the videos. I have been busy and it's time consuming to download the videos and create links to share them. I hope that the images you will see is enough evidence to create urgency in addressing the health and safety issues that are being created due to not having a physical barrier between 18th Dr and the strip shopping center. I already have three convictions for trespassers. I have called the police several times to report more incidents and have a case pending, IR2020454860 for a trespasser on 3/15/20. Many of the transients do not have any fear of spreading diseases as you will see in the videos below. Would a sound barrier wall be another alternative? My neighbors and I are at our wits' end with this situation. All we want is a safe and clean street. Please help!

Hi Leticia,

Happy Friday! I hope you are doing well and staying healthy. The D3 office has been working from home, and we're all staying healthy.

I just sent an email to check with Streets. The Councilwoman and I met with the directors of the Streets Department and Planning and Development Department about two months ago to discuss options for 18th Drive. The Streets director said he would put together a packet of information on the process to abandon the street and any costs involved, including a possible estimate for a wall. Also two months ago, the councilwoman, Lisa Huggins and Officer Kornegay conducted a CPTED audit (Crime Prevention Through Environmental Design) of the shopping plaza. The officer was going to produce a report—I'm checking in about that as well.

I'll let you know what updates I receive, and we'll look out for your videos.
