This responds to your Freedom of Information Act (FOIA) request for all dissent memoranda or complaints, including ethics or whistleblower complaints, regarding events at the U.S. Capitol, U.S. National Mall, or surrounding grounds in Washington D.C. on January 6, 2021. We received your request on August 19, 2021, and assigned it case number DODOIG-2021-001259.

The Administrative Investigative Component to include the Defense Hotline Directorate, conducted a search and located the attached records responsive to your request. Upon review, we determined that records are appropriate for release in part pursuant to FOIA (5 U.S.C. § 552) exemptions (b)(6), when the disclosure of such information would constitute a clearly unwarranted invasion of personal privacy and (b)(7)(C), which protects personal information in law enforcement records.

The documents will be sent via email. Given the nature of the responsive records, we have password protected the file. The password will be sent to you in an email separate from the responsive records. If you are unable to retrieve the records, please contact us, and we can send via a different method.

Please be advised that the search conducted by the Investigations of Senior Officials Directorate located documents that may be responsive to your request. However, they are compiled for law enforcement purposes and release, at this time, could reasonably be expected to interfere with an enforcement proceeding. As such, 5 U.S.C. § 552 (b)(7)(A) of the FOIA provides for withholding records or information compiled under these circumstances, as law enforcement proceedings are not limited to criminal actions but include civil actions and regulatory proceedings as well. For this reason, we cannot release those documents at this time. Once the enforcement proceeding is complete however, exemption (b)(7)(A) may no longer apply, and you may re-submit your request. Please note that, even after the enforcement proceeding is completed, responsive records may still be exempt from disclosure based on one or more FOIA exemptions.

He called into meetings from the protest before it got more extreme, and was scheduled for meetings during the rest of the day. I do not believe he has actually posted any secure information from work, but the claims about AI / DoD knowledge and nobody knowing the real picture combined with the usual Q Anon theories are an alarming combination. The use of work hours to attend a protest/riot are more concrete, but may be a good reason to check in on the situation in general as he becomes more extreme.


