An exclusive for the Daily Caller if you're interested, under embargo until the bill is signed which will be at approximately 4pm MST tomorrow. I'll follow up to let you know when that is –

Governor Gianforte will be signing legislation tomorrow afternoon to ban sanctuary cities in Montana. The bill, HB200, prohibits local jurisdictions from adopting sanctuary policies and penalizes jurisdictions should they choose not to comply. Similar legislation was previously vetoed by former Governor Steve Bullock in
