Good afternoon

This letter is in response to your request under the Freedom of Information Act sent on February 3, 2022 wherein you requested copies of documents as noted in the first attachment to this email. The second attachment is your later, revised list of search criteria. We sent an estimate and received the required deposit equal to half of the estimate made by our IT team. The search was performed by our IT staff in less time than initially expected, and a refund is owed to you in the amount of \$33.85 and will be processed on the next possible Township bill run. We will keep you updated on that progress and notify you when the payment is sent.

Our IT staff performed the search as described in your communications, using the 75 search criteria per your amended list first sent to us on February 15, 2022. The Clerk Stanley Grot does not have known Township accounts on any of the messaging platforms named in your description of Requested Records, nor does he have any known Township accounts on any messaging platforms not named by you. The search was performed on his Township email account – sgrot@shelbytwp.org - for the time frame required in your request, for the criteria exactly as requested, and no communications were found between Clerk Stanley Grot and the individuals and/or accounts or domains in your list.
