The Legislative Task Force on Redistricting, Reapportionment, and Demographic Research (“Task Force”) is authorized under ORC 103.51 “notwithstanding any provision of law to the contrary” to “[r]equest and receive from any state agency or political subdivision of this state such assistance and data as will enable the task force to exercise its powers and duties under this section.” We, the undersigned Co-Chairs of the Task Force hereby authorize and direct the director of the Legislative Service Commission to pay expenses submitted to the Task Force in the following manner:

**Caucus Allocation of Funds**

Each pair of legislative caucuses is allocated funds for the purchase of hardware, software, physical space, supplies, and contract technical and legal services related to redistricting processes.

This authority is limited at this time to \$150,000 for each pair of caucuses (\$75,000 per individual caucus) and is valid for expenses incurred prior to June 30, 2022. The caucuses of each party may choose to split their \$150,000 allotment. More funds may be allocated to the caucuses later as need arises.

**Payment of Expenses**

Any expenses incurred by the caucuses must be submitted for approval to the offices of the Task Force Co-Chairs accompanied by documentation of the expense.

The payment of other expenses incurred by the Task Force will require documentation of the expense and approval of both Task Force Co-Chairs. The director of the Legislative Service Commission shall facilitate payment of any expense approved by the Task Force Co-Chairs. As these will not be expenses incurred by the Legislative Service Commission, ORC 103.21 will not apply.

Dear President Huffman:

As the census count comes to a close in Ohio and across our nation, I write to ask you as Co-Chair of the Legislative Task Force on Redistricting, Reapportionment and Demographic Research to work with me to allocate resources to the four legislative caucuses to allow them to begin preparations for the redistricting process.

According to recent statements from the Census Bureau, the apportionment numbers have been delayed to Feb. 9<sup>th</sup> which could significantly delay the release of all subsequent data shortening our timeline. The most pressing task before us right now is to allocate resources to the legislative caucuses for expenditures such as up-to-date equipment, updating of expired mapping software licenses, and contractors to provide technical and legal services to the caucuses. And unlike other redistricting cycles, the ongoing spread of the coronavirus will necessitate the consideration of staff continuing to work from home and the possible need for multiple computers, licenses and printers. Planning for these funds now will ensure a smoother start to this process.

I am including again the funds allocation letter for both our signatures so that our caucuses can begin preparations for fair districts in our state. Thank you for your time and attention.
