I am writing to you concerning the OSHA Emergency Temporary Standard (ETS) for mandatory COVID vaccination that was filed in the Office of the Federal Register on November 4, 2021. Along with many other employers throughout Florida and across the United States, we have significant concerns with the impact of this ETS on our business. Your litigation challenging that ETS is well reasoned and timely.

Sugar Cane Growers Cooperative of Florida is a cooperative of forty-one family-owned farms that employs over six hundred Floridians and is an integral part of the food supply throughout the United States. We recently began our 60th harvest season, which runs through April, 2022. We have already dealt with labor shortages and believe that requiring our employees to be vaccinated, along with the administrative burden of verifying status, testing results, etc., could bring our business to a halt.
