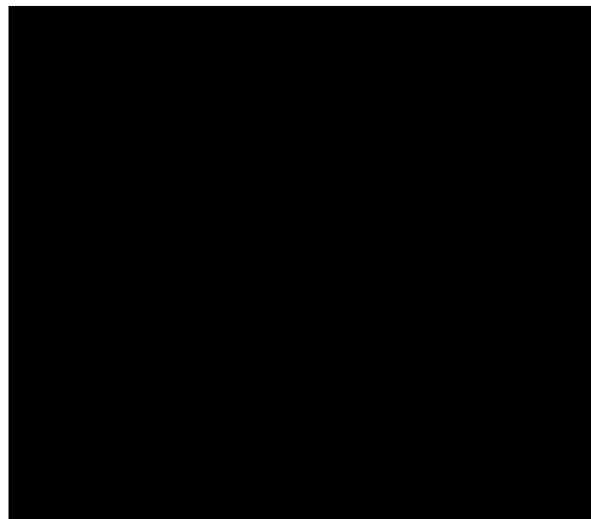

Dear John,

Like many of you, I watched yesterday's insurrection at our nation's Capitol building with horror. The mob attack that occurred against the seat of our democracy runs counter to our nation's values and has no place in society. Those involved must now face the full force of the justice system they claim to support.

Ultimately, our democracy won the day because of the courage and patriotism of the men and women who risked their lives to secure the Capitol, the brave journalists who recorded history, and the lawmakers who returned to complete their constitutionally mandated work to certify the presidential election results.

Those who fanned the flames of disinformation and distrust, contributing to this mob, will live forever under history's eye. That includes Chapman University Professor John Eastman, a visiting scholar in our Benson Center for Western Civilization, Thought and Policy, who spoke at the rally that preceded the riot at the Capitol. His continued advocacy of conspiracy theories is repugnant, and he will bear the shame for his role in undermining confidence in the rule of law.

I have heard the requests that I dismiss him. In considering this question, I first look at the Board of Regents' policies, which state that the university will not censor a faculty member's political statements or initiate disciplinary action because it disapproves of them. That policy stems from the First Amendment, which protects even abhorrent or ignorant political speech and prevents public employers from taking adverse action. Yesterday, we learned the high price of disregard of the law and the Constitution. I will not violate the law by removing a visiting professor from a position that he will occupy at most for only a few more months, as his contract will expire in May.

However, Professor Eastman's conduct does not reflect the values of our university. He has embarrassed our institution. CU Boulder is committed to the free exchange of ideas and the pursuit of knowledge, and Professor Eastman has contributed nothing of value to support the ideals of either the Benson Center or CU Boulder.

As a campus and country, we need to move forward. Now that our nation's election has been affirmed, our republic will be renewed through the orderly transition of power to President-elect Biden and Vice President-elect Harris on Jan. 20.

Even so, we have more difficult days and weeks ahead, and our need for courage heading into this transition remains.

As a nation and a community, we need to heal the damage caused by this election and the political dynamics. The stakes for our society are too high for us to continue down this divisive path. Let's use this moment in history as a rallying cry to rebuild the foundation of our nation that was laid more than two centuries ago. Let's make this a time of renewal, healing and unity for our democracy. Let's work together and draw from the strength that blossoms in the most trying times.

As for topic/title, how about: What does Trump's Presidency Portend for the Future of Conservatism in America?

President Trump really upset the status quo in D.C.. If court challenges go his way, he will continue to do so for another 4 years, but even if not, his presidency has had a profound impact on America. First, the restoration of constitutionalism in the courts, where the words of the Constitution actually bind the branches of government rather than serving as so much putty to be molded for current, avante garde agendas. Second, a serious (though not yet remotely successful) pushback against an unelected and unaccountable administrative state, with the hope of restoring policy-making power to the elected legislative branch (and, ultimately, to the people). Third, a restoration of a foreign policy that pursues America's interests in the world rather than, as had increasingly become the case, some nebulous (or even nefarious) globalism. Those are advances that every constitutional conservative should welcome, and should continue to work to advance.

One negative, though, and that is the disinclination of Trump to tackle the ever-expanding federal budget. The deficit itself is obscene, but the accumulated debt is now taking on proportions so large as to likely enslave future generations of Americans. Particularly when one realizes that much of spending by the federal government is not even constitutional--the spending power is limited to things for the "common defense and general welfare"--this is one area of focus to which conservatives need to re-dedicate themselves.

John,

I had quite a convincing vision of how I would prevail over the challenges presented by my schedule this week, but there seems to be a gap between that vision and my arrangements for tomorrow. The point of decision came when I realized that, by the best possible outcome, I would arrive at your party in the vicinity of 8:30 p.m. This would present you and Elizabeth with the misery of having to tell me that you were just about to shift over, in the post-

party manner, to reminiscing about the thought-provoking ideas that had been aired and the fine time everyone had had at your gathering. So I am surrendering the vision!

This is a vexation for any number of reasons. The primary reason is that I was very much looking forward to getting to know you and Elizabeth, but I am banking on having quite a few more opportunities in that zone over the year. The secondary reason is that I was hoping to have the opportunity to tell you, in person, about an idea I have for a public program. This is a program I have wanted to host for years, but I am finally reaching the recognition that the program will not happen unless I actually start trying to orchestrate it!

So here's the background for the idea.

Sometime in the late 1980s and early 1990s, I took up the not-very-precisely defined role of "a public intellectual." That role has provided me with many satisfactions, but also with a few significant and lasting vexations. I believe I have identified what distinguishes the outcome of satisfactions from the outcome of vexations. When I have, as a public intellectual, put forward a proposition or assertion and I have been able to keep control of my message, I have had a wonderful time, with the pleasure persisting through criticism and controversy. When I have put forward a proposition or assertion, and others, without my invitation or permission, have taken possession of my statement (often quoting it out of context), my lot has been frustration, annoyance, and high-powered vexation.

So that brings us to the forum that I want to hold.

The two-part question: 1) How much responsibility do public intellectuals have to shepherd, steer, or control their messages when they make a statement in a public arena? 2) How much authority and power do public intellectuals actually *have* to perform the shepherding, steering, and controlling of this message?

I have been involved with the Center for Western Civilization since its origins, and I would be happy to have that Center host this discussion. And I am the Faculty Director of another CU center--the Center of the American West--and I would also be happy to have my Center host this event, maybe in co-sponsorship with the Benson Center.

And now I am tempted to offer a prolonged explanation of why I am so eager to host such a forum, but I will stop here and await your response. and it is my guess that this is the lengthiest and most complicated RVSP you have ever received for a social gathering!

Hey John and Elizabeth:

Hope you're both well and remaining safe. I had a brief conversation with outgoing director Bob Pasnau and incoming director Dan Jacobson about how to manage events in the fall and possibly into the spring. John,

I had quite a convincing vision of how I would prevail over the challenges presented by my schedule this week, but there seems to be a gap between that vision and my arrangements for tomorrow. The point of decision came when I realized that, by the best possible outcome, I would arrive at your party in the vicinity of 8:30 p.m. This would present you and Elizabeth with the misery of having to tell me that you were just about to shift over, in the post-party manner, to reminiscing about the thought-provoking ideas that had been aired and the fine time everyone had had at your gathering. So I am surrendering the vision!

This is a vexation for any number of reasons. The primary reason is that I was very much looking forward to getting to know you and Elizabeth, but I am banking on having quite a few more opportunities in that zone over the year. The secondary reason is that I was hoping to have the opportunity to tell you, in person, about an idea I have for a public program. This is a program I have wanted to host for years, but I am finally reaching the recognition that the program will not happen unless I actually start trying to orchestrate it!

So here's the background for the idea.

Sometime in the late 1980s and early 1990s, I took up the not-very-precisely defined role of "a public intellectual." That role has provided me with many satisfactions, but also with a few significant and lasting vexations. I believe I have identified what distinguishes the outcome of satisfactions from the outcome of vexations. When I have, as a public intellectual, put forward a proposition or assertion and I have been able to keep control of my message, I have had a wonderful time, with the pleasure persisting through criticism and controversy. When I have put forward a proposition or assertion, and others, without my invitation or permission, have taken possession of my statement (often quoting it out of context), my lot has been frustration, annoyance, and high-powered vexation.

So that brings us to the forum that I want to hold.

The two-part question: 1) How much responsibility do public intellectuals have to shepherd, steer, or control their messages when they make a statement in a public arena? 2) How much authority and power do public intellectuals actually *have* to perform the shepherding, steering, and controlling of this message?

I have been involved with the Center for Western Civilization since its origins, and I would be happy to have that Center host this discussion. And I am the Faculty Director of another CU center--the Center of the American West--and I would also be happy to have my Center host this event, maybe in co-sponsorship with the Benson Center.

And now I am tempted to offer a prolonged explanation of why I am so eager to host such a forum, but I will stop here and await your response. and it is my guess that this is the lengthiest and most complicated RVSP you have ever received for a social gathering!

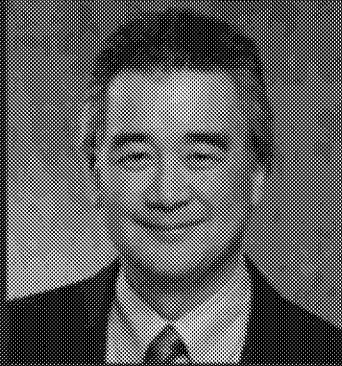
