For parts 1 and 2 of this request, please provide all responsive records from March 1, 2021, through the date the search is conducted.

On July 22, 2022 the Office determined that there are documents responsive to your request, in accordance with S.C. Code Ann. § 30-4-30(C), and requested a \$19 deposit to proceed with your request.

On August 8, 2022, we received your deposit.

The records responsive to your request are attached.

Please be advised, we have not provided any of the documents that contained your search terms because they were clearly not relevant to the subject of your request. For example, one email contains the term “plan b” when discussing options for vehicles; another email from a constituent contains the term “precedent” when talking about covid guidelines for children; and another email contains the name Ella, for a person, and is not referencing the contraceptive drug Ella. Please let us know if you meant for your request to include these documents. If you do want these documents, please be advised that some of these documents will be exempt from production or subject to redaction in accordance with exemptions provided for by § 30-4-40, or other state or federal laws.
