Hello,
I have attended a few presentations sponsored by Citizens for Election Integrity Texas because of my own concerns over election irregularities in Tarrant County. On Tuesday evening there was a very powerful presentation, and I believe you were among the invited officials. I'm sorry you could not be there.

There is zero confidence in our elections in Tarrant County and particularly if one researches the background and history of Mr. Heider Garcia. It is astounding to me that this gentleman was the one chosen to oversee our elections when brief research into elections in Venezuela provides evidence of questionable outcomes.
