Hi Kelli,

This is the update on the audit we have been conducting with the Records office. It supports the issues being found with the full audit being done now.

On the 2018 Primary, we found major discrepancy between the Voted File provided to us by the Recorder. They said it was a mistake on their end so they resent the file. Upon further review we found major issues with that file, which we were then given an "3rd version" of the results. On that file we found the Records Office manipulated the files to match the canvas. This manipulation included CHANGING peoples voting status from Voted to Not Voted, and also the opposite Not Voted to Voted. We have proof manipulating the voter file is something that office does.

As you can see below none of the last 8 elections have been reconciled for accuracy, and the chart show how many votes each election was off. The 2020 elections are the only election where the amount off was short of the Official Canvas. All these numbers should be exact. We broke down the discrepancy's to the precinct levels so we can identify where the votes were are off. We are currently preparing the information for our lawsuit against the Records office.

(This is the email we sent yesterday to the Records Staff. We are still waiting for their response.)

The following table lists the ballots cast count from the VM55 files provided in Feb. I compared the total ballots cast with the AZ SOS canvas for those elections. Not ONE of the files tied! Most of the elections had more votes in the file than what was recorded on the canvas; however, both the primary and general elections in 2020 had fewer ballots cast in the file than what was recorded on the canvas.

Additionally, I compared at the precinct level the Aug. 2018 file last updated on 04/19/21 to the public file provided on the Recorder's office. The VM55 file was missing ballots cast for precincts 376, 605, 615-619. The total "turnout" per the "Total" column for these precincts per the public file was 3,933. Additionally, precincts 744-748 were missing from the public file but included (with ballots cast) in the VM55 file. Lastly, only 88 precincts tied perfectly in the ballots cast, while all others had discrepancies. Some of the discrepancies were more than a thousand under or over. Here's a small example:

The same type of analysis was performed on the **Nov. 2020 election**. Again, there were discrepancies; however, there were no missing precincts between the two files this time. Here's another small sample:

I've tried to keep up with you through the chaos of the post election mess.


We have been heavily involved in a confidential research project that may be of interest to you given the day you have had.

It's a long story that started in San Luis, Arizona, then to Georgia, back to Maricopa County and on the Milwaukee, Detroit and Texas and Pennsylvania.

Long story short we have spent more than a million dollars proving our hypothesis. I can now prove how it all happened.

In one day, this ballot harvester in Atlanta went to five ballot stash houses and 28 ballot drop boxes in six counties. We have 5,859 of these in Atlanta during the run off alone.
