Thank you for the below information directing us to the audio recordings of meetings of the Boards of Medicine and Osteopathic Medicine.

Our public records request asked for the following information:

“All final assessments, reports, analyses, recommendations, or guidance in your possession (including formal memoranda and other written products) prepared by your office or otherwise provided to your agency by other state or local offices, or by independent experts, regarding any projected or actual impacts of changing regulations governing the treatment of gender dysphoria for children and adolescents.”

I'd note that our request asked for “all” such assessments in your possession. Based on your response to our request, directing us to discussions at board meetings, are we to understand that there are such written records that might be responsive?

Further, our request had asked for responsive records from April 20, 2022, through the date the search was conducted. For our awareness, could you please let me know the date the search was conducted so we can understand what the time frame used was?
